SECTION XIV
EMISSION INVENTORY DEVELOPMENT

The comprehensive emissions inventory for calendar year 1977 is shown as Tables XIV.1 through XIV.5. Initially it will include only the nonattainment areas; however, as soon as the data are compiled, the inventory for the remainder of the State will be included.

Beginning at the end of calendar year 1979, the inventory will be compiled each year.
