SUBJECT: Standard Operating Procedure for Nominating, Selecting and Prioritizing

Chemical Substances for the Development of Provisional Peer-Reviewed Toxicity

Values

The purpose of this memorandum is to introduce the Standard Operating Procedure for nominations, selection and prioritizing chemical substances (for assessment or reassessment) for the Provisional Peer-Review Toxicity Values (PPRTVs).

The PPRTVs are developed by the Office of Research and Development, National Center for Environmental Assessment. The PPRTVs are a human health assessment that evaluates quantitative and qualitative risk information on effects (if sufficient information is available) that may result from exposure to specific chemical substances released into the environment. The PPRTVs are developed for EPA's Superfund Program when such a value is not available in the Integrated Risk Information System (IRIS). PPRTVs are considered the Tier 2 source of toxicity information for waste cleanup programs under OSWER Directive 9285.7-53 *Human Health Toxicity Values in Superfund Risk Assessments*.

A Standard Operating Procedure (SOP) outlining the annual process for nominating and selecting chemicals to review by the PPRTV program has been developed as a coordinated effort between the Office of Land and Emergency Management and the Superfund Human Health Risk Assessment Technical Support Center. The SOP outlines the formation of a PPRTV Scoping

Team that will collaborate to nominate chemicals, select a candidate list, and prioritize the chemicals for PPRTV development. The goals of this effort are to emphasize development of high-quality deliverables based on the most current OLEM and Regional needs and optimize the expenditure of fiscal resources and human capital for assessment activities related to priority chemicals.

There will continue to be two processes by which to nominate and select a chemical: (1) standard annual nomination and selection, and (2) emergency request for an accelerated addition of a chemical for development. Attached to this memo please find a copy of the SOP and the Chemical Nomination Form.
