In accordance with Section 309(g) of the Clean Water Act (CWA), 33 U.S.C. § 1319(g) AND 40 CFR § 22.45, notice is hereby given that the U.S. Environmental Protection Agency Region III (EPA Mid-Atlantic Region), is proposing to file a Consent Agreement and Final Order (CAFO) assessing an administrative civil penalty in the amount of forty-five thousand dollars (\$45,000) against the Respondent named below for alleged violations of its NPDES permit.

**SUMMARY OF VIOLATIONS**: EPA Mid-Atlantic Region alleges the following violations of National Pollutant Discharge Elimination System (NPDES), Construction General Permit No. DCR12A240 (Permit): 1) Failure to Post Notice of Permit Coverage; 2) Failure to Implement Maintenance Requirements; 3) Failure to Provide Natural Buffers or Equivalent Sediment Controls; 4) Failure to Protect Drain Inlets; 5) Failure to Store, Handle and Dispose of Construction Products, Materials and Wastes; 6) Failure to Inspect at the Proper Frequency; 7) Failure to Complete Corrective Action Reports; and 8) Failure to Have the SWPPP Available On-Site.

These failures constitute a violation of Section 301(a) of the CWA, 33 U.S.C. §§ 1311(a). These violations were discovered during an NPDES inspection of Respondent's MRP Capitol River Front construction site in May 2016.

**OPPORTUNITY FOR COMMENT**: Persons wishing to comment on the amount of the proposed penalty are invited to submit a statement to the EPA Mid-Atlantic Region Water Protection Division Director, addressed to the attention of the Regional Hearing Clerk (address below), within 40 days of the date of this public notice. Comments received within this 40 day period will be considered. All comments must include the name, address, and telephone number of the writer and a concise statement of the basis for any comment and any relevant facts on which it is based.
