Please provide more training on Proposal Cost Preparation Policy and explain why GAP is capped at 5% when grantwriting is essential to program establishment.	AlEO worked closely with the Regions to provide tribal program comments to the Office of Grant and Debarment while the EPA Policy on Direct Charges for Proposal Preparation Costs was unde development. The general rule in 2 CFR 200.460, applicable across federal agencies and various recipient groups, is that proposal preparation costs will normally be covered as indirect costs. EPA's final policy carves out exceptions to this general rule, including that for GAP, recipients car directly charge proposal preparation costs associated with applications for a wide range of funding sources. This flexibility for GAP recipients is broader than the exceptions for other EPA Continuing Environmental Program grants. The final EPA policy provides that "Proposal preparation costs must bear a reasonable relationsh to the total budget and in no event exceed 5% of the total budget (which includes both EPA's share and any cost share/match by the recipient) for the agreement to meet the reasonableness requirement. However, OGD, after consulting with the National Program Manager and OGC, may provide an exception to this limitation based on extraordinary circumstances." If a GAP recipient wishes to request direct charges for proposal preparation costs that exceed 5% of the total awar budget, the recipient should contact their Project Officer for guidance. In order for the Region to request an exception, the recipient will need to provide a justification for the exception (description of why the exception is needed, any extenuating circumstances that may prevent compliance with the 5% limitation), information the project officer specifies, and any additional background information that may help EPA to make a determination.
