Brownfields Definition

EPA Region 1 Brownfields

"... real property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of hazardous substances, pollutants, contaminants, controlled substances, petroleum or petroleum products, or is mine-scarred land."

Hazardous Substances
Petroleum Contamination
Asbestos & Lead Paint
Controlled Substances (e.g., Meth labs)
Mine-Scarred Lands
Other environmental contaminants


- 40 Cleanup Grants \$ 11 Million

Proposal Guidelines



- ► The Brownfields Utilization, Investment, and Local Development (BUILD) enacted in March 2018.
 - Local & state government acquisition of sites no longer has to be "involuntary".
 - Removed "of relative low risk" from petroleum eligibility.
 - Bona Fide Prospective Purchasers (BFPP) expanded to include tenants and leaseholders.
 - Non-Profits can apply for Assessment, Multipurpose & RLF grants.
 - Cleanup grant applicants can apply for up to \$500,000 per site.

BUILD Act Summary

- Multipurpose (assessment & cleanup funds) grants are available for up to \$1,000,000.
- Administrative costs up to 5% of grant award are allowed.
- New criteria for renewable energy & energy efficient projects and waterfront development.

EPA Region 1 Brownfields

Oh no, they changed the Guidelines again!!!

Now they are shorter, clearer, and better!!!

What's New - General

- Everything is new Forget about previous guidelines.
- Multipurpose grants are available as a pilot program.
- No RLF Grants this year. Will be available in FY2020.
- Can allocate up to 5% of requested funds for direct and/or indirect administrative costs. See FAQs N.1-12.
- Threshold Criteria have been revised and expanded.
- Ranking Criteria have been reduced to 4 items.
- Ranking Criteria page limit is now 10 pages (12 pages for Multipurpose Grants).

- Demographic table has been eliminated.
- Support letters from community organizations are no longer required.
- For Regional Organizations that have previously applied for and/or received a grant, you cannot change your Type of Applicant on the SF424 to a nonprofit. See FAQs B.12.
- A complete list of changes to the Guidelines can be found in FY19 FAQs A.1.

What's New – Assessment Grants

- You cannot also apply for a Multipurpose Grant.
- Non-profits and LLCs & LLPs comprised of non-profits [501(c)(3)] and community development organizations [45D(c)(1)] are now eligible entities.
- Area-Wide Planning is now part of Assessment Grants. See pages 4-5 of the Assessment Guidelines, <u>FAQs</u> F.4, and <u>Planning Program Fact Sheets</u>.
- Community-wide applicants can now apply for up to \$300,000 of hazardous substances and/or petroleum funding.

- Current assessment grantees must have drawn down at least 70% of the funds from each of their grants by January 1, 2019 in order to apply for additional assessment funding.
 - For a \$400,000 grant, you must have less than \$120,000 remaining.

What's New – Assessment Grants

- For a \$300,000 grant, you must have less than \$90,000 remaining.
- For a \$200,000 grant, you must have less than \$60,000 remaining.
- See <u>FAQs</u> 1.1-14.

You cannot also apply for a Multipurpose Grant.

What's New – Cleanup Grants

- Previous Cleanup Grant recipients cannot apply for more funding for the same site. See <u>FAQs</u> K.3.
- You can only submit one cleanup proposal that addresses one or more sites for a maximum of \$500,000.
- ▶ This year there will be no waivers of the \$500,000 limit.
- Tribes, nonprofit organizations, and government entities with populations of 50,000 or fewer can request a waiver of the 20% cost share.
- Revised threshold criteria for Exemptions to CERCLA Liability.
- See <u>FAQs</u> K.1-17.

What's New – Multipurpose Grants

- Multipurpose grants combine assessment & cleanup funds in one grant.
- This is a pilot program this year. Only 10 grants will be awarded nationwide.
- You cannot also apply for an Assessment or Cleanup grant.
- You can apply for up to \$800,000 to complete at least:
 - One Phase II assessment;
 - One cleanup; and
 - A plan for revitalization.

What's New – Multipurpose Grants

- You will be required to provide a \$40,000 cost share.
- If you allocate at least 70% of funds to site-specific work including site assessment, remediation and associated tasks and at least \$200,000 for remediation, you will be evaluated more favorably.
- You must own a site that meets the CERCLA definition of a Brownfields site.
- ► See FAQs L.1-7.
