Brendan Warn (BMO Capital):

Then just further on that point of fiscal change, since obviously the US tax reduction, where does that country now rank? Has it moved up in the positioning? How much more attractive has it made investing into the US?

Bob Dudley:

And you asked about the American business system now with lower taxes – what does it mean?

This is important for BP because we have been, over the last decade, America’s largest energy investor – \$90 billion of capital over the last decade. That is separate and aside from the \$65 billion of obligations with Macondo.

So if you take what was one of the highest tax rates in the OECD at 35%, take it down to 21%, this is of course of enormous value to business in many ways. Net present value to BP is affected by this, despite these short-term charges and things that everyone is trying to sort out. So it is important for us. There is no doubt we will increase investments.

I imagine I can speak for... because I am around a lot of the US business community, the regulatory system of the United States is suddenly so much easier. It was becoming an avalanche of regulations in every direction, so permitting required sequential federal and state, and now they are in parallel.

Decisions are going to be made faster, and if they are not made faster, then, the infrastructure programmes they are talking about will not happen.

So from a business community standpoint it is quite transformation. There will be a lot of capital attracted to the US because of it in my opinion, and not just speaking from a BP perspective.




I am writing to express concern about the status of the Environmental Protection Agency (EPA)'s draft Integrated Risk Information System (IRIS) assessment of formaldehyde. The National Academy of Sciences harshly criticized the methodology that the EPA used to identify, evaluate and integrate the large and multi-disciplinary body of scientific studies related to the potential carcinogenicity of formaldehyde. Since 2011, the Agency has been working to revise the 2010 draft formaldehyde IRIS assessment in response to numerous substantive recommendations made by the National Academy of Sciences (NAS).

The Agency should produce regulation that protects human health from the dangers of toxic chemicals, and it should ensure that those regulatory requirements are grounded in a thorough and objective review of all the relevant scientific evidence and economic impact. I recently had the opportunity to tour one of the largest formaldehyde manufacturing plants in the country, which is located in my state. It was a reminder of the influence the facility has on the surrounding community, in addition to the many building and construction and automotive applications of this chemical.

It is my understanding that the University of North Carolina (UNC) is hosting an important scientific workshop in October, focused on a discussion of several compelling new scientific studies and new analyses of existing studies, which may have called into question the validity of the Agency's findings. A scientifically flawed, but influential, IRIS assessment will have a devastating economic impact. Furthermore, without a clear understand of the health risks associated with formaldehyde we could potentially expose the surrounding communities to even greater health risks.

For these reasons, I am respectfully requesting that you commit to withholding any further action on the development of the draft IRIS assessment of formaldehyde until the findings from the upcoming science workshop at UNC are fully considered and those findings are appropriately incorporated. It is my hope the deliberations of this important workshop will help inform the Agency on how to appropriately integrate the best available human and animal data to draw conclusions about potential cancer risks.

Before the risk values embedded in the Agency's assessment are used in regulatory decision making, I encourage the Agency to ensure that the regulations governing the manufacturing of formaldehyde are grounded in sound science. To me, the health and safety of the community is a paramount concern. Acting without the best or accurate science will leave a devastating impression on the American people that the Agency cannot take lightly.

- Based on an overflight with infrared cameras, the release appears to be contained to the gravel pad surrounding the wellhead and has not reached the tundra.

BPXA, Alaska DEC, U.S. EPA and North Slope Borough Form Unified Command in Response to Oil and Gas Well Discharge Near Prudhoe Bay, Alaska

Report as of 3:00 pm AKDT on 15 April 2017, Note: All times are Alaska Time

A Unified Command, consisting of responders from Alaska Department of Environmental Conservation (ADEC), U. S. Environmental Protection Agency (U.S. EPA), the North Slope Borough, and BP Exploration Alaska (BPXA) has been established to respond to the BP Flow Station 1 Drill Site 2 Well 3 natural gas and crude oil discharge near Prudhoe Bay, Alaska. The Unified Command will ensure safe and efficient coordination of resources and information amongst BPXA and state and federal regulators. To date, there have been no injuries and no reported impacts to wildlife.

BPXA Well 3 is located in the Greater Prudhoe Bay area, approximately 5 miles from the Deadhorse Airport on Alaska's North Slope. On April 14, 2017, at approximately 7:30 am, BPXA employees discovered an uncontrolled gas release from the top of Well 3. At approximately 8:15 am, BPXA confirmed the crude spray from the top of the well house and reported the spill to ADEC via the Fairbanks spill reporting line and to U.S. EPA via the National Response Center.

The well is currently venting gas, which caused a spray of crude to impact the well pad. A Forward Looking Infrared or FLIR overflight shows that the crude spray plume did not leave the pad, however, the situation is not safe yet for responders to access the area and confirm that there have been no impacts to adjacent tundra. No volume estimate for crude spray released is available at this time. Two leaks have been identified on the well, one near the top and one further down the well assembly. The top leak was misting oil in conjunction with releasing natural gas, but the activation of the surface safety valve has stopped the release from this point. The bottom leak is currently

leaking gas as well as some minor amount of crude oil. The well structure is housed in a metal "well house" which is helping to contain any oil spray.

ADEC and U.S. EPA have mobilized response personnel to the Unified Incident Command Post located on the North Slope. Responders attempted to secure the well last night, however, this operation was unsuccessful due to safety concerns and damage to a well pressure gauge. Continuous air monitoring has been established around the well, and the situation remained stable overnight. Responders are not able to safely assess the impacted area until the well has been controlled.

The Unified Command continues working to formulate a plan to bring the well under control. Once well control has been achieved, BPXA will work with their Oil Spill Response Organization, Alaska Clean Seas (ACS), to delineate the impacted area. Cleanup plans will be developed through the Incident Command System and with guidance from the Unified Command.

The cause of the discharge is unknown at this time. ADEC and U.S. EPA are coordinating with BPXA and the Alaska Oil and Gas Conservation Commission to investigate the cause of the discharge, following the securing of the well.



Background Information

- Atlantic Richfield never owned or operated a facility on the East Chicago property.
- A different company that later merged into the Anaconda Company operated at the site until 1946, when it sold the property along with the building and manufacturing facilities. Numerous companies operated industrial facilities at the property during the more than two-decade gap between Anaconda's sale of the property in 1946 and the sale of the property to the East Chicago Housing Authority in 1970. In addition, other companies operated entirely separate lead-related businesses in the vicinity of the East Chicago property.

- In 1977, more than 30 years after the Anaconda Company ceased operations and sold the property, and years after the sale to the Housing Authority, Atlantic Richfield acquired Anaconda.
- As the successor to Anaconda, Atlantic Richfield has assumed certain responsibilities related to the environmental clean-up of the property. Atlantic Richfield has worked cooperatively with the EPA for many years on remediation efforts at the site, including the 2014 Consent Decree that Atlantic Richfield signed along with DuPont/Chemours and the Administrative Order on Consent signed last month. Atlantic Richfield is pleased that United States Metals Refining Company has joined Atlantic Richfield and DuPont/Chemours in contributing to cleanup costs and efforts. Atlantic Richfield is hopeful that other responsible parties will soon step forward as well.
- Through the 2014 consent decree, Atlantic Richfield and DuPont agreed to spend an estimated \$21 million to pay EPA's costs to excavate and remove contaminated soil in Zone 1 (the West Calumet housing complex) and Zone 3 (the eastern portion of the Site), and to properly dispose of the soil. Last month's Administrative Order on Consent provides millions of dollars to fund the EPA's efforts to remove contaminated soil from Zone 2 (the central portion of the Site) and perform indoor dust sampling and cleaning on residential properties in Zones 2 and 3.
- All remediation of the East Chicago site is being directed by the EPA.
