Consent Agreement and Final Order

Preliminary Statement

1. This is an administrative action commenced and concluded under Section 14(a) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), 7 U.S.C. § 136l(a), and Sections 22.13(b) and 22.18(b)(2) and (3) of the *Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits* (Consolidated Rules) as codified at 40 C.F.R. Part 22.

2. The Complainant is the Director of the Land and Chemicals Division, U.S. Environmental Protection Agency, Region 5.

3. The Respondent is Medline Industries, Inc. (Medline), a corporation doing business in the State of Illinois.

4. Where the parties agree to settle one or more causes of action before the filing of a complaint, the administrative action may be commenced and concluded simultaneously by the issuance of a consent agreement and final order (CAFO). 40 C.F.R. § 22.13(b).

5. The parties agree that settling this action without the filing of a complaint or the adjudication of any issue of fact or law is in their interest and in the public interest.

6. Respondent consents to the assessment of the civil penalty specified in this CAFO, and to the terms of this CAFO.

Jurisdiction and Waiver of Right to Hearing

7. Respondent admits the jurisdictional allegations in this CAFO and neither admits nor denies the factual allegations in this CAFO.
8. Respondent waives its right to request a hearing as provided at 40 C.F.R. § 22.15(c), any right to contest the allegations in this CAFO, and its right to appeal this CAFO.
9. Respondent certifies, to the best of its knowledge, that it is complying with FIFRA, 7 U.S.C. §§ 136 to 136y.

Statutory and Regulatory Background

10. Section 3(a) of FIFRA, 7 U.S.C. § 136a(a), states that no person in any State may distribute or sell to any person any pesticide that is not registered under Section 3 of FIFRA.
11. Section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A), states it is unlawful for any person in any state to distribute or sell to any person any pesticide that is not registered under Section 3 of FIFRA.
12. Section 2(s) of FIFRA, 7 U.S.C. § 136(s), defines the term “person” as “any individual, partnership, association, corporation, or any organized group of persons whether incorporated or not.”
13. Section 2(gg) of FIFRA, 7 U.S.C. § 136(gg), defines the term “distribute or sell” as “to distribute, sell, offer for sale, hold for distribution, hold for sale, hold for shipment, ship, deliver for shipment, release for shipment, or receive and (having so received) deliver or offer to deliver.” Also see 40 C.F.R. § 152.3.
14. Section 2(u) of FIFRA, 7 U.S.C. § 136(u), defines the term “pesticide” as, among other things, “any substance or mixture of substances intended for preventing, destroying, repelling, or mitigating any pest.” Also see 40 C.F.R. § 152.3.

15. Section 2(t) of FIFRA, 7 U.S.C. § 136(t), defines the term “pest” as “any insect, rodent, nematode, fungus, weed, or any other form of terrestrial or aquatic plant or animal life or virus, bacteria, or other micro-organism which the Administrator [of the EPA] declares to be a pest” under Section 25(c)(1) of FIFRA. Also see 40 C.F.R. § 152.5.

16. Section 2(y) of FIFRA, 7 U.S.C. § 136(y), defines the term “registrant” as a person who has registered any pesticide pursuant to the provisions of FIFRA.

17. Section 14(a)(1) of FIFRA, 7 U.S.C. § 136l(a)(1), states that any registrant, commercial applicator, wholesaler, dealer, retailer or other distributor who violates any provision of FIFRA may be assessed a civil penalty by EPA of not more than \$7,500 for each offense that occurred after January 12, 2009 through November 2, 2015. The Federal Civil Penalties Inflation Adjustment Act of 1990, as amended through 2015, 28 U.S.C. § 2461, and its implementing regulations at 40 C.F.R. Part 19, increased the amount that can be assessed to \$19,446 for each offense occurring after November 2, 2015 and assessed after January 15, 2018.

See 83 Fed. Reg. 1190 (January 10, 2018).

Factual Allegations and Alleged Violations

18. Respondent is a “person” as defined at Section 2(s) of FIFRA, 7 U.S.C. § 136(s).

19. Respondent is a “registrant” as defined at Section 2(y) of FIFRA, 7 U.S.C. § 136(y).

20. At all times relevant to this CAFO, Respondent owned or operated a place of business, with its corporate headquarters located at Three Lakes Drive, Northfield, Illinois 60093 (Northfield facility).

21. On or about June 7, 2017, inspectors employed by the U.S. EPA and authorized to conduct inspections under FIFRA conducted an inspection at Respondent’s Northfield facility.

22. During the inspection, the inspectors collected the following information regarding the product **Micro-Kill 70 Isopropyl Alcohol Wipes**.

- a. An inventory list of **Micro-Kill 70 Isopropyl Alcohol Wipes** that was being held for distribution or sales at various Medline branches.
- b. Records of distribution or sales of **Micro-Kill 70 Isopropyl Alcohol Wipes** from August 7, 2015 through May 30, 2017.
- c. A copy of the **Micro-Kill 70 Isopropyl Alcohol Wipes** label.
- d. A brochure entitled “Medline Micro-Kill™ Disinfectant Wipes,” which was identified as MKT1549667.
- e. A brochure entitled “Medline Micro-Kill™ Disinfectant Wipes,” which was identified as MKT1670473.

23. Prior to the inspection, one of the U.S. EPA inspectors was able to find the following information regarding the product **Micro-Kill 70 Isopropyl Alcohol Wipes**:

- a. Ordering information, literature, product specification and Safety Data Sheets for **Micro-Kill 70 Isopropyl Wipes** on that product’s page on www.medline.com on or about April 21, 2017.
- b. The brochure identified as MKT1549667 on www.medline.com on or about April 21, 2017.
- c. The brochure identified as MKT1670473 on www.medline.com on or about April 21, 2017.

24. The label collected at the inspection identified **Micro-Kill 70 Isopropyl Alcohol Wipes** as “MEDLINE MICRO-KILL™ 70” and “70% ISOPROPYL ALCOHOL WIPES.”

25. The label also included a pictorial of a petri dish in the letter "O" in the words "Micro-Kill," as shown below:

26. Respondent made at least the following statements¹ regarding **Micro-Kill 70 Isopropyl Alcohol Wipes** on www.medline.com.

27. Both brochures are entitled "**Medline Micro-Kill™ Disinfectant Wipes Helping Reduce the Spread of Infectious Germs.**"

28. The cover of both brochures pose the question: "**ARE YOU WINNING THE GERM BATTLE?**"

29. The background of the cover of both brochures also contain depictions of micro-organism, such as spores, viruses, bacteria or germs, as shown below:

30. Both brochures contain information on **Micro-Kill 70 Isopropyl Alcohol Wipes**.
31. Both brochures state "EFFECTIVE DISINFECTION AT YOUR CONVENIENCE."
32. Both brochures state:

"Medline's comprehensive line of disinfectant wipes help to reduce the chance for cross-contamination and transmission of infectious microorganisms on a variety of surfaces, patient care equipment and point-of-care equipment."
33. Both brochures state:

"Using Micro-Kill disinfectant wipes ensures:

 - The proper concentration of solution is delivered every time to achieve surface disinfection.
 - Effective disinfection of hard-to-kill microorganisms on hard, non-porous surfaces.
 - Durability to handle hard surface scrubbing and hold enough disinfectant to ensure maximum surface coverage."
34. Both brochures describe **Micro-Kill 70 Isopropyl Alcohol Wipes**.
35. Specifically, the brochures state **Micro-Kill 70 Isopropyl Alcohol Wipes** "Cleans Delicate Instruments ... Common Uses Made with 70% Isopropyl Alcohol (IPA), Micro-Kill 70 wipes are ideal for delicate digital technology, as well as all surfaces."

36. Both brochures state:

“THE SOLUTION TO ALL YOUR DISINFECTANT NEEDS. Micro-Kill, Medline’s comprehensive line of disinfectant wipes help to reduce the chance for cross-contamination and transmission of infectious microorganisms on a variety of surfaces and medical instruments. Choose the wipes that are right for your needs.”

37. This language is followed by a Table that lists six products in the Micro-Kill line of products and includes five EPA registered products and **Micro-Kill 70 Isopropyl Alcohol Wipes.**

The Website: www.medline.com, on or about April 21, 2017

38. In addition to the brochures, the website at www.medline.com made additional statements² regarding **Micro-Kill 70 Isopropyl Alcohol Wipes.**

39. **Micro-Kill 70 Isopropyl Alcohol Wipes** was listed under a product category page entitled “Disinfectants.”

40. **Micro-Kill 70 Isopropyl Alcohol Wipes** was found at the website address:
www.medline.com/product/Micro-Kill-70-Isopropyl-Alcohol-Wipes/Disinfectants/Z05-PF19234.

41. Under the “specifications” of **Micro-Kill 70 Isopropyl Alcohol Wipes**, Medline’s website identified the “active ingredient” of the product to be “isopropanol.”

42. “Micro-Kill” is an express claim that the product, **Micro-Kill 70 Isopropyl Alcohol Wipes**, will kill microbes.

43. The brochures and information found on www.medline.com imply that the product, **Micro-Kill 70 Isopropyl Alcohol Wipes**, will kill microbes.

44. Therefore, **Micro-Kill 70 Isopropyl Alcohol Wipes** is a “pesticide” as that term is defined in Section 2(u) of FIFRA, 7 U.S.C. § 136(u), because it is intended for preventing, destroying, repelling, or mitigating certain pests.

45. **Micro-Kill 70 Isopropyl Alcohol Wipes** is not a registered pesticide as required by Section 3 of FIFRA and its underlying regulations.

Distribution or Sales of Micro-Kill 70 Isopropyl Alcohol Wipes

46. From on or about August 7, 2015 through on or about May 30, 2017, Respondent distributed or sold **Micro-Kill 70 Isopropyl Alcohol Wipes** to various persons on 1,291 separate occasions. See Attachment A.

Post – Inspection Events

47. On February 7, 2018, Complainant issued a Stop Sale, Use or Removal Order (SSURO) to Respondent.

48. On March 28, 2018, Complainant issued a *Notice of Intent to File an Administrative Complaint against Medline Industries, Inc.* (Prefiling Notice) to Respondent.

49. On or about February 28, 2018, Medline changed the name of the product from **Micro-Kill 70 Isopropyl Alcohol Wipes** to **Touch Screen Cleaning Wipes** and removed any express or implied pesticidal claims from the label, Medline’s literature and Medline’s website.

50. Medline has sent a letter to its customers informing them of the change and offered to provide customers replacement labels to re-sticker any existing stock in the customers’ possession.

Counts 1-1,291

51. Complainant incorporates the above paragraphs of this Complaint, as if set forth in this paragraph.

52. From on or about August 7, 2015 through on or about May 30, 2017, Respondent distributed or sold the unregistered pesticide, **Micro-Kill 70 Isopropyl Alcohol Wipes**, to various persons on 1,291 separate occasions. See Attachment A.

53. Respondent's distribution or sale of the unregistered pesticide, **Micro-Kill 70 Isopropyl Alcohol Wipes**, on 1,291 separate occasions constitutes 1,291 separate unlawful acts pursuant to Section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A).

54. Respondent's violation of Section 12(a)(1)(A) of FIFRA, 7 U.S.C. § 136j(a)(1)(A), on 1,291 separate occasions subjects Respondent to the issuance of an Administrative Complaint assessing a civil penalty under Section 14(a) of FIFRA, 7 U.S.C. § 136l(a), for each of the 1,291 violations.

Civil Penalty and Other Relief

55. Section 14(a)(4) of FIFRA, 7 U.S.C. § 136l(4), requires the Administrator to consider the size of the business of the person charged, the effect on the person's ability to continue in business, and the gravity of the violation, when assessing an administrative penalty under FIFRA.

56. Based on an evaluation of the facts alleged in this CAFO, the factors in Section 14(a)(4) of FIFRA and EPA's Enforcement Response Policy for the Federal Insecticide, Fungicide, and Rodenticide Act, dated December 2009, Complainant has determined the appropriate penalty to settle this action is \$4,930,000.

57. Within 30 days after the effective date of this CAFO, Respondent must pay a \$4,930,000 civil penalty for the FIFRA violations. Respondent must pay the penalty by electronic funds transfer, payable to the "Treasurer, United States of America," and sent to:

58. This civil penalty is not deductible for federal tax purposes.
59. If Respondent does not pay the civil penalty in a timely manner, EPA may refer the matter to the Attorney General who will recover such amount by action in the appropriate United States district court under Section 14(a)(5) of FIFRA, 7 U.S.C. § 136l(a)(5). The validity, amount and appropriateness of the civil penalty are not reviewable in a collection action.

60. Pursuant to 31 C.F.R. § 901.9, Respondent must pay the following on any amount overdue under this CAFO. Interest will accrue on any amount overdue from the date payment was due at a rate established by the Secretary of the Treasury. Respondent must pay a \$15 handling charge each month that any portion of the penalty is more than 30 days past due. In addition, Respondent must pay a 6 percent per year penalty on any principal amount 90 days past due.

General Provisions

61. Consistent with the Standing Order Authorizing E-Mail Service of Orders and Other Documents Issued by the Regional Administrator or Regional Judicial Officer under the Consolidated Rules, dated March 27, 2015, the parties consent to service of this CAFO by e-mail at the following valid e-mail addresses for their respective attorneys: omeara.nidhi@epa.gov (for Complainant), and DElliott@cov.com and ALberman@medline.com (for Respondent). The parties waive their right to service by the methods specified in 40 C.F.R. § 22.6.

62. This CAFO resolves only Respondent's liability for federal civil penalties for the violations and facts alleged in this CAFO.

63. This CAFO does not affect the right of EPA or the United States to pursue appropriate injunctive or other equitable relief or criminal sanctions for any violations of law.

64. This CAFO does not affect Respondent's responsibility to comply with FIFRA and other applicable federal, state, and local laws.

65. This CAFO is a "final order" for purposes of EPA's Enforcement Response Policy for FIFRA.

66. The terms of this CAFO bind Respondent, its successors, and assigns.

67. Each person signing this agreement certifies that he or she has the authority to sign for the party whom he or she represents and to bind that party to its terms.
68. Each party agrees to bear its own costs and attorney's fees, in this action.
69. This CAFO constitutes the entire agreement between the parties.
