Public Notice: Capitol Products Corporation - Mechanicsburg, PA

**PURPOSE OF THIS NOTICE:** The U.S. Environmental Protection Agency (EPA) announces its proposed cleanup decision that natural attenuation with:

- 1) groundwater monitoring,
- 2) land and groundwater use restrictions,

and 3) compliance with a Pennsylvania Department of Environmental Protection January 27, 1995 Consent Order and Agreement is required under the Resource Conservation and Recovery Act,

as amended (RCRA)

for the former Capitol Products Corporation (Facility).

**FACILITY DESCRIPTION**: The former Capitol Products Corporation facility is located at 6034 Carlisle Pike (Route 11), Mechanicsburg, PA 17055. Primarily, the constituents of concern are benzene, 1,1-dichloroethene, cis/trans 1,2-dichloroethene, trichloroethene, 1,1,1-trichloroethane,

1,1-dichloroethene, cis/trans 1,2-dichloroethene, trichloroethene, 1,1,1-trichloroethane tetrachloroethene, and vinyl chloride.

Demolition, redevelopment, soil excavation and remediation, and groundwater monitoring, as described in the Statement of Basis, have occurred at the Facility since 1994.

**COMMENT PROCESS:** Persons to comment on EPA's proposed decision must submit comments to EPA within the 30-day comment period ending **Wednesday**, **April 24**, **2019**. Interested persons may also request a public hearing on this proposed remedy. All comments and/or requests for a hearing must be submitted in writing via mail, fax, or email to the EPA Project Manager, Kevin Bilash, as listed above, and must be received prior to **Wednesday**, **April 24**, **2019** All comments will be considered in making a final decision.

**FINAL DECISION:** EPA will make a final decision after considering all comments, consistent with applicable RCRA requirements and regulations. If the remedy is substantially unchanged from the one in this notice, EPA will issue a final decision and inform all persons who submitted written comments or requested notice of EPA's final determination. If the remedy is significantly different from the one proposed, EPA will issue a public notice explaining the new remedy and will reopen the comment period.
