The Environmental Cheminformatics group at the Luxembourg Centre for Systems Biomedicine at the University of Luxembourg will use the analytical standards provided to establish and verify analytical and computational methods for target and non-target mass spectrometry to verify results of the ENTACT project and to generate data for internal use as well as for the public domain. Any data release into the public domain will be verified with the Provider in advance.

- 5. In all oral presentations or written publications concerning the Research Project, Recipient will acknowledge Provider's contribution of this Research Material unless requested otherwise. To the extent permitted by law, the Parties agree to treat as confidential and not to disclose to any third party, any of the other Party's written information about the Research Material and/or Research Results and that is stamped "CONFIDENTIAL" for a period of three (3) years from the date of its disclosure to the receiving Party. The foregoing shall not apply to information that is or becomes publicly available or which is disclosed to the receiving Party without a confidentiality obligation, which was already in lawful possession of the receiving Party prior to disclosure, or if its disclosure is required by law, regulation or any governmental or competent regulatory authority, provided that the receiving Party has (i) notified the providing Party on the proposed form, timing, nature, purpose and extend of the disclosure and (ii) used reasonable efforts to protect the confidential information by procedural measure. Any oral disclosures from the providing Party to the receiving Party, which the providing Party wishes to be treated as confidential shall be identified as being Confidential at the time of the disclosure and by written notice delivered to the receiving Party within thirty (30) days after the date of the oral disclosure. The receiving Party may publish or otherwise publicly disclose the results of the Research Project, but if the providing Party has given Confidential information to The receiving Party, such public disclosure may be made only after the providing Party has had thirty (30) days to review the proposed disclosure to determine if it includes any Confidential information, to the extent such review period is permitted by law.
- 6. This Research Material represents a significant investment on the part of Provider and is considered proprietary to Provider. Recipient's investigator therefore agrees to retain control over this Research Material and further agrees not to transfer the Research Material to other people not under his/her direct supervision without advance written approval of Provider. Provider reserves the right to distribute the Research Material to others and to use it for its own purposes. When the Research Project is completed, the Research Material will be returned to the Provider or disposed, if directed by Provider.
