The meeting will be held at NEI's office at 1201 F Street, NW, Suite 1100, Washington, DC (across the street from the Metro Center metro station.)

The meeting is scheduled to run from 9 a.m. through approximately 4 p.m. A copy of the current draft agenda is attached for convenience.

NEI is the organization responsible for establishing unified policies on matters affecting the nuclear energy industry. NEI's members include all entities licensed to operate commercial nuclear power plants in the United States, nuclear plant designers, major architect/engineering firms, fuel cycle facilities, nuclear materials licensees, and other organizations and entities involved in the nuclear energy industry.

**Do let us know if you plan to use slides.** If so, we would appreciate having them before the meeting (preferably by noon on Monday, November 13) to add to the master slide deck.


