DESCRIPTION OF APPLICANT'S FACILITY AND DISCHARGE

The above named applicant has applied for an NPDES Permit to discharge into the designated receiving water. The facility is located within the boundries of the Lower Sioux Indian Reservation. The EPA has retained authority to issue NPDES permits to facilities with discharges to waters of the United States within Indian Country.

Treatment Facility Description:

The waste water treatment facility (WWTF) is designed to treat an average wet weather flow of 0.375 mgd and consists of preliminary treatment, an activated sludge process, tertiary treatment and chlorine disinfection. Preliminary treatment consist of a fine rotary screen, manual bar screen and gravity manual grit removal. The activated sludge process is a 3 basin extended air process with chemical feed for phosphorus removal, 2 final clarifiers and a solids recycling and wasting structure. Tertiary treatment consists of pumping the final clarifier effluent through a 3-cell horizontal pressure filter, then into a contact basin for chlorine disinfection, sulfur dioxide for dechlorination, and post aeration for dissolved oxygen control. Backwash water for the pressure filter is pumped from the chlorine contact basin and wasted into the solids recycling structure where it is pumped back through the activated sludge process. The discharge is continuous through Outfall 001 (Lat: 44.514750 Long: -94.985378) to an unnamed tributary to Wabasha Creek. Waste solids are treated in a covered aerobic digester with seasonal land

application on agricultural land within the reservation. There is a back-up generator to power the WWTF during emergency conditions. This WWTF replaced a 5-cell stabilization lagoon. Though the cells are still in place, they are prohibited from discharging directly to surface waters. The primary aeration cell can still be used to accept peak flows beyond plant capacity or during times of upset. Wastewater in the aeration cell is pumped back to the head of the WWTF for full treatment.

TENTATIVE DETERMINATION

On the basis of preliminary staff review and application of applicable standards and regulations, the Regional Administrator of EPA, Region 5 proposes to reissue a permit for the discharge from the Lower Sioux Indian Community WWTF subject to certain effluent limitations and special conditions.

COMMENT PROCEDURES and PUBLIC HEARING

The determination to issue the NPDES permit is tentative. EPA's comment and public hearing procedures may be found at 40 CFR 124.10, 124.11, 124.12, and 124.13. The following is a summary of those procedures:

- 1. The comment period during which written comments on the draft permit may be submitted extends to October 22, 2019.
- 2. During the comment period, any interested person may request a public hearing by filing a written request which must state the issues to be raised. The last day for filing a request for public hearing is October 22, 2019. EPA will hold a hearing if there is significant interest based on written requests. Public notice of such a hearing will be circulated in at least one newspaper in the geographical area of the discharge and to those persons on the EPA mailing list at least 30 days prior to the hearing.
- 3. All comments postmarked after October 22, 2019 will not be considered in the formulation of the final determination.

The application and Public Notice numbers should appear next to the EPA address on the envelope and on each page of any submitted comments. It is important that all viewpoints are considered before taking action. Therefore, we greatly appreciate your time and effort in participating in the public participation process. Please bring the foregoing to the attention of persons whom you know would be interested in this matter. Unless a public hearing is scheduled, the EPA will issue a final determination as to the issuance of the permit in a timely manner after the expiration of the public comment period. If you would like to receive a copy of the final determination, please submit a request during the comment period to the above address.

EPA will notify the applicant and each person who has submitted written comments or requested notice of the final permit decision.

PETITION TO REVIEW

Within 30 days following the service of notice of the Regional Administrator's final permit decision, any person who filed comments on the draft permit or participated in a public hearing, if held, may petition the Environmental Appeals Board (EAB) to review any condition of the permit decision. Such a petition must include a statement of the reasons supporting review of the decision, including a demonstration that the issue(s) being raised for review were raised during the public comment period (including any public hearing). The petition should, when appropriate, show that each condition being appealed is based on either, (1) a finding of fact or conclusion of law which is clearly erroneous, or (2) an exercise of discretion or an important policy demonstration which the EAB should, in its discretion, review.

AVAILABILITY OF DOCUMENTS

The application, draft permit, including proposed effluent limitations and special conditions, statement of basis, and other documents contained in the administrative record, are available for inspection and may be copied at a cost of 15 cents per page at the Chicago Regional offices of the Environmental Protection Agency anytime between 9:00 a.m. and 4:00 p.m., Monday through Friday.
