Dear Mr. Dragovich,

On behalf of the City of Columbus and project "Olentangy River Road 24" Water Main Phase 1, we are requesting a waiver for the required Flex Ring fittings. These ductile iron fittings are only produced outside of the United States. We have contacted all the manufacturers known to providing this style of fitting. We have worked with American Pipe Company and the City of Columbus to eliminate some of the tee fittings by allowing them to weld outlets onto the pipe. We will still have 19 fittings that will need a waiver.

We have reach out to the SRF research team and provided them with the necessary documentation so they could do their own research also. I have read through your requirements and are providing the following attachments in this email:
