
USER FEES FOR FY2020/2021

- We have announced upcoming e-Manifest user fees for Fiscal Years 2020 and 2021 (effective October 1, 2019, through September 30, 2021).
- These user fees are set based on the projected manifest usage rates and program costs during this period.
- Any manifest that originates (signed by the generator) on or after October 1, 2019, will be charged the fiscal years 2020 and 2021 user fee rate when submitted to the e-Manifest system by the receiving facility.
- Receiving facilities will see their first invoices reflecting the new rates starting in November 2019.

- June 18-20, 2019, e-Manifest Advisory Board Public meeting held in Arlington, VA.
- Meeting Theme: "Increasing Adoption of the e-Manifest System"
- Public Docket Number: EPA-HQ-OLEM-2019-0194 (available at www.regulations.gov)
- The final Meeting minutes/Board recommendations are currently available in the public docket.

INVOICE QUESTION

- I submitted an image only manifest but now I see it on my site as image + data. Should I be charged the lower rate?
- You will be charged at the rate it was initially submitted. When the PPC pulls the data from the image only manifest, it is marked "image + data" in our system (because the data is now searchable).
- To find the initial submission type, please check Version 1 of your manifest.

SYSTEM DEVELOPMENT UPDATES

- Recently added to Production
 - In support of FY 2020/21 user fee changes, added ability to provide generator site information and paper signed date on image manifests to ensure facilities are charged correctly

- Split out services and endpoints on Swagger by user type: All, Industry, State
- Added Generator Name to invoice manifest list
- Updated Receiving Facility and the Import City/Port lookup maintenance to display Site Name and City in Description, in addition to automatically updating when source record changes
- Added foreign generator mailing address to services, fixed a bug with TX waste codes

SYSTEM DEVELOPMENT UPDATES (CONT'D)

- Recently added to Pre-Production for User Testing
 - Added more links to help on the manifest pages
 - Additional help text and asterisks based on feedback from the RCRAInfo Conference
 - Modifications to invoice to break out FY18/19 and FY20/21 fees
 - Adjustments for State Corrections
 - Added a field to the emanifest.json on whether the site can e-Sign
- Functionality under development
 - Broker/Transporter
 - State corrections
 - Notifications
