TCI of Alabama LLC (TCI) has applied to the U. S. Environmental Protection Agency for renewal of their Approval to commercially store polychlorinated biphenyls (PCBs) under Section 6(e)(1) of the Toxic Substances Control Act (TSCA), 15 U.S.C. 2605(E) and 40 CFR § 761.65 (d). PCB regulation currently falls under the exclusive authority of the EPA.

TCI provides utilities and major industries with equipment decommissioning, dismantling, disposal, and recycling services at their facility located in Pell City, Alabama. The waste management activities at TCI includes cleaning and processing transformers and metals contaminated with PCBs. TCI's PCB operations include on-site sampling, oil draining, fluid disposal, dismantling, and advanced metal cleaning/recycling process, cable processing, PCB analysis, natural gas pipe disposal and light ballast recycling.

TCI operates a commercial storage area in accordance with § 761.65(d) and alternate decontamination procedures outlined in § 761.79(h) for the PCB wastes. The EPA has completed its review of the TCI renewal application for the commercial storage and alternate decontamination of PCB waste and has prepared a proposed TSCA PCB Approval. The proposed TSCA PCB Approval sets forth conditions for managing PCB waste, establishes facility closure procedures, and requires TCI to maintain financial assurance to cover facility closure cost for the PCB waste and storage areas. The EPA has determined that the application meets the requirements set forth in the regulations and that operation of the facility in accordance with the requirements of the TSCA PCB Approval will not pose an unreasonable risk of injury to health or the environment.

Persons wishing to comment on the EPA's decision to issue the proposed TSCA PCB Approval are invited to submit comments by letter or email during the public comment period beginning **December 17, 2019 and ending January 21, 2020**. The EPA will finalize its decision after review of and response to all received written comments. A copy of the draft TSCA PCB Approval is available at the EPA's public notice website at www.epa.gov/aboutepa/about-epa-region-4-southeast.
