

## Attachment D: Checklist for CAA Tribal Air Grant Applications EPA Region 10

Budget items are appropriately categorized by the Object Class Categories on the SF-424A and consistent with the guidance provided in Attachment B of the RFA.

All costs correspond correctly across the workplan, detailed budget, SF-424, and SF-424A.

Any costs specified in the detailed budget that need prior approval (i.e., equipment and travel) are also shown in the proposed workplan.
