Thank you for the opportunity to respond to the issues and recommendations in the subject audit report. Following is a summary of the agency’s overall position, along with its position on each of the report recommendations. For those report recommendations with which the agency agrees, we have provided high-level intended corrective actions and estimated completion dates to the extent we can. For those report recommendations with which the agency does not agree, we have explained our position, and proposed alternatives to recommendations.

AGENCY’S OVERALL POSITION

We will take corrective action to address the recommendations in the report. For one recommendation, we disagree and are proposing an alternative corrective action.

2	<p>The OIG recommendation would result in duplicative effort to provide information that is already in the public domain because there are several existing, accessible portals that provide this information. Information about regulatory actions is available in the Semiannual Regulatory Agenda. Since all regulatory actions are reviewed by OMB, they are also listed on reginfo .gov when review begins and when review concludes. This site is updated daily. Regulatory actions are frequently announced by the EPA, covered in the press, and pre-publication versions of the actions are often posted online shortly after they are signed. Finally, regulatory actions are published in the Federal Register; the Federal Register website is also updated daily. In contrast, not all deregulatory actions go through all these steps, which is why EPA established a dedicated website where they are all listed in one place.</p>	<p>In addition to maintaining existing sources of information on EO 13771 regulatory actions, EPA will establish a new web page that will list the final regulatory actions as they are completed. EPA will establish the web page by Q2 FY20.</p>
