## Public Notice: Former BP Oil, Inc. Marcus Hook Refinery - Trainer, PA

## DATE OF THIS NOTICE: 2/24/2020

**PURPOSE OF THIS NOTICE:** The United States Environmental Protection Agency (EPA) is announcing its proposed decision (Statement of Basis) for the Former BP Oil, Inc. Marcus Hook Refinery (Facility) in Trainer, PA, as required by the Resource Conservation and Recovery Act (RCRA). The proposed decision relies on engineering controls as well as land and groundwater use restrictions to ensure protection of human health and the environment. The Facility property will continue to be used solely for non-residential purposes and groundwater beneath the Facility property will not be used for potable, agricultural or commercial purposes.

## **Summary of Proposed Action:**

**RCRA Corrective Action - Cleanup Proposal** 

**FACILITY DESCRIPTION:** The 350-acre Facility has been operated as a petroleum refinery since the early 1900s and is currently owned/operated by Monroe Energy (2012-Present). The refinery has historically produced gasoline, kerosene, diesel fuel, residual fuel oils, bunker C fuel, aviation fuel, and liquefied petroleum gas and has a current process capacity of approximately 200,000 barrels per day. Although BP Oil, Inc. sold the Facility in 1996, it retained responsibility for certain environmental conditions that existed at the time of the sale.

**COMMENT PROCESS:** Persons to comment on EPA's proposed decision must submit comments to EPA within the 30-day comment period ending **3/25/2020.** Interested persons may also request a public hearing on this proposed remedy. All comments and/or requests for a hearing must be submitted in writing via mail, fax, or email to the EPA Project Manager, Andrew Clibanoff as listed above, and must be received prior to **3/25/2020.** All comments will be considered in making a final decision.

**FINAL DECISION:** EPA will make a final decision after considering all comments, consistent with applicable RCRA requirements and regulations. If the remedy is substantially unchanged from the one in this notice, EPA will issue a final decision and inform all persons who submitted written comments or requested notice of EPA's final determination. If the remedy is significantly different from the one proposed, EPA will issue a public notice explaining the new remedy and will reopen the comment period.
