Funding Priority - Fiscal Year 2019: Partnerships - Establishing and developing partnerships with states, local governments and other non-profit organizations to assist them in advancing their waste management programs, including recycling and reduction of wastes, appropriate management of wastes that are generated and developing integrated waste management plans. Education and Outreach - Developing and providing education, training, and outreach materials to educate and inform Americans about the impact of waste on resource and energy use and pollution. Fostering a better understanding of the environmental ramifications of collective actions including how individual purchasing and manufacturing decisions are connected to the environment and to enable Americans to make better choices resulting in increased recycling, less waste and greater energy savings.

**DATES:** The closing date and time for the receipt of applications is April 17, 2020, by 11:59 pm, Eastern Time (ET) in order to be considered for funding. Application packages must be submitted electronically to Grants.gov (<a href="https://www.grants.gov">https://www.grants.gov</a>) on or before this date and time in order to be considered for funding. See Section III(C)(2) for more details about the deadline and Section IV(B) for submission instructions.

**SUMMARY:** This notice announces the availability of funds and solicits applications that support the EPA Sustainable Materials Management Program. Applications may benefit States or communities throughout EPA Region 2 (New York, New Jersey, Puerto Rico, the U.S. Virgin Islands) however, all applications **must benefit** Puerto Rico and/or the U.S. Virgin Islands. Sustainable materials management (SMM) is a systemic approach to using and reusing materials more productively over their entire life cycles. It represents a change in how our society thinks about the use of natural resources and environmental protection. By looking at a product's entire life cycle, we can find new opportunities to reduce environmental impacts, conserve resources and reduce costs. Developing markets for reused and/or recycled materials also falls under this domain.

Specifically, these funds will support training, demonstrations, and public education projects for the development of programs that support the sustainable management of organic waste and/or construction and demolition debris. While this RFA is open to cover all of EPA Region 2, i.e. New York, New Jersey, Puerto Rico and the U.S. Virgin Islands, it is essential that Puerto Rico and/or the U.S. Virgin Islands benefit from the proposed project.

**FUNDING/AWARDS:** The total estimated funding for this competitive opportunity is approximately \$100,000. We anticipate making one to three awards with the available funds.

# I. Funding Opportunity Description

# A. Background

Sustainable Materials Management (SMM) is a systemic approach to using and reusing materials more productively over their entire life cycles. It represents a change in how our society thinks about the use of natural resources and environmental protection. By examining how materials are used throughout their life cycle, an SMM approach seeks to:

- Use materials in the most productive way with an emphasis on using less,
- Reduce toxic chemicals and environmental impacts throughout the material life cycle,
- Assure we have sufficient resources to meet today's needs and those of the future.
- Develop markets for reused or recycled materials.

How our society uses materials is fundamental to our economic and environmental future. Global competition for finite resources will intensify as world population and economies grow. More productive and less impactful use of materials helps our society remain economically competitive, contributes to our prosperity and protects the environment in a resource-constrained future.

The SMM program has a number of program foci and these serve as the basis for our structuring of grant competitions. This RFA derives its program justification from the **Sustainable**Management of Food program priority and the Built Environment program priority.

Applications may address either or both priorities.

Sustainable Management of Food is a systematic approach that seeks to reduce wasted food and its associated impacts over the entire life cycle, starting with the use of natural resources, manufacturing, sales, and consumption and ending with decisions on recovery or final disposal. EPA works to promote innovation and highlight the value and efficient management of food as a resource. Through the sustainable management of food, we can help businesses and consumers save money, provide a bridge in our communities for those who do not have enough to eat, and conserve resources for future generations. Building on the familiar concept of "Reduce, Reuse, Recycle," this approach shifts the view on environmental protection and more fully recognizes the impacts of the food we waste.

In addition, other organic wastes such as yard trimmings, organic disaster debris, manure, and other types organic materials can also be beneficially diverted, in conjunction with food waste, from the waste stream through SMM strategies (e.g., composting or anaerobic digestion).

EPA's organics management program uses the food recovery hierarchy to represent an overarching philosophy of resource conservation: <a href="https://www.epa.gov/sustainable-management-food/food-recovery-hierarchy">https://www.epa.gov/sustainable-management-food/food-recovery-hierarchy</a>. As such, we encourage organics diversion to take place with activities as high up on the hierarchy as possible. Source reduction, otherwise known as waste prevention, is always the most protective of resource expenditure.

Construction and Demolition (C&D) materials consist of the debris generated during the construction, renovation, and demolition of buildings, roads, and bridges. EPA promotes an SMM approach that identifies certain C&D materials as commodities that can be used in new building projects, thus avoiding the need to mine and process virgin materials. EPA calls this program focus the **Built Environment.** 

C&D materials are generated when new building and civil-engineering structures are built and when existing buildings and civil-engineering structures are renovated or demolished (including deconstruction activities). Civil-engineering structures include public works projects, such as streets and highways, bridges, utility plants, piers, and dams. C&D materials often contain bulky, heavy materials such as concrete, wood, asphalt, bricks, and other energy-intensive resources. SMM practices to help manage the built environment include the following:

- Beneficially using industrial non-hazardous secondary materials as replacements for virgin materials in construction (e.g. coal ash, foundry sand, iron and steel slag, etc.)

- Best Practices for Reducing, Reusing, and Recycling C&D Materials https://www.epa.gov/smm/best-practices-reducing-reusing-and-recycling-construction-and-demolition-materials.

This RFA solicits applications for training, demonstration, and public education projects that address an SMM approach to managing either or both organics and C&D waste. Submitted applications may address organics and/or C&D waste Region-wide but must benefit Puerto Rico and/or the U.S. Virgin Islands.

SMM follows the waste reduction hierarchy: <a href="https://www.epa.gov/smm/sustainable-materials-management-non-hazardous-materials-and-waste-management-hierarchy">https://www.epa.gov/smm/sustainable-materials-management-non-hazardous-materials-and-waste-management-hierarchy</a> As such, projects that support waste diversion strategies higher up on the hierarchy will receive extra points, as reflected in the evaluation criteria. Source reduction and donation/reuse will be valued more highly than other strategies.

Fundable projects must involve training, demonstrations, and/or public education programs that address strategies to beneficially use organics and C&D waste. Organizations may submit more than one application as long as each one is separately submitted. Projects may benefit States or communities throughout EPA Region 2 (New York, New Jersey, Puerto Rico, the U.S. Virgin Islands) however, all projects <u>must benefit</u> Puerto Rico and/or the U.S. Virgin Islands.

# B. Scope of Work

As noted above in Section I.A, this RFA solicits applications that support training, demonstrations or public education programs for delivering sustainable approaches to managing organics and/or C&D waste. Applications addressing other topic areas will not be reviewed.

# C. EPA Strategic Plan Linkage & Anticipated Outcomes, Outputs & Performance Measures

The activities to be funded under this announcement are intended to further EPA's current goal of Cooperative Federalism, with the subobjective of Enhanced Shared Accountability, as SMM grants are intended to bolster and support State and local autonomy and the ability to improve human health and the environment in their jurisdictions with a sense of shared accountability to provide positive environmental results. All applications must demonstrate these connections to the current Strategic Plan. Applicants must show how their project will further these current priorities.

EPA also requires that grant applicants adequately describe environmental outputs and outcomes to be achieved under assistance agreements (see EPA Order 5700.7, Environmental Results under Assistance Agreements, <a href="https://www.epa.gov/grants/epa-order-57007a1-epas-policy-environmental-results-under-epa-assistance-agreements">https://www.epa.gov/grants/epa-order-57007a1-epas-policy-environmental-results-under-epa-assistance-agreements</a>). Applicants must include specific statements describing the environmental results of the proposed project in terms of well-defined outputs and, to the maximum extent practicable, well-defined outcomes that will demonstrate how the project will contribute to the priorities described above.

**Outputs.** The term "output" means an environmental activity, effort, and/or associated work product related to an environmental goal and objective that will be produced or provided over a period of time or by a specified date. Outputs may be quantitative or qualitative but must be measurable during an assistance agreement funding period. Expected outputs from the project(s) to be funded under this announcement may include the following: meetings, conference calls, training sessions, or other measurable efforts towards an environmental goal. Progress reports and a final report will also be required outputs, as specified in Section VI(C) of this announcement, "Reporting Requirements."

**Outcomes.** The term "outcome" means the result, effect or consequence that will occur from carrying out an environmental program or activity that is related to an environmental or programmatic goal or objective. Outcomes may be environmental, behavioral, health-related, or

programmatic in nature, but must be quantitative. They may not necessarily be achievable within an assistance agreement funding period.

Projects to be funded under this announcement are expected to produce at least one of the following environmental outcomes: reduction in solid waste going to the landfill, conservation of natural resources, conservation of energy, reduced costs, improved air and/or water quality, or preserved land quality.

**Performance Measures.** The applicant must also develop performance measures they expect to achieve through the proposed activities and describe them in the application. These performance measures will help gather insights and will be the mechanism to track progress concerning successful process and outcome strategies and will provide the basis for developing lessons to inform future recipients. It is expected that the description of performance measures will include the following: a measure of how much solid waste will be diverted from the landfill and by what strategy and a description of how policy and behaviors will be permanently altered as a result of this project. The following are questions to consider when developing output and outcome measures of quantitative and qualitative results.

- i) What are the measurable short term and longer-term results that the project will achieve?
- ii) How does the plan measure progress in achieving the expected results (including outputs and outcomes) and how will the approach use resources effectively and efficiently?

## **D.** Supplemental Information

The statutory authority for this action is the Solid Waste Disposal Act (SWDA), Section 8001(a)(5), 42 U.S.C. Section 6981(a)(5) which authorizes grants to public authorities, agencies, and institutions, private agencies and institutions, and individuals (no profit makers) for purposes which include conducting and promoting the coordination and acceleration of, research, investigations, experiments, training, demonstrations, surveys, public education programs and studies relating to the reduction of the amount of solid waste and unsalvageable waste materials.

Applications selected for funding under this solicitation must be consistent with the authorizing statute above. Under this solicitation, appropriate projects for funding by our program are limited to training, demonstrations, and public education projects. Demonstrations must involve new or experimental methods or approaches where the results of the project will be disseminated so that others can benefit from the knowledge gained in the demonstration project. A project that is accomplished through the performance of routine, traditional, or established training practices, or a project that is simply intended to carry out a task rather than transfer information or advance the state of knowledge, however worthwhile the project might be, is not considered a demonstration project; such activities are not eligible for funding under this announcement. You must specify how your training, demonstration or public education project fits within the above statutory authority.

## **E. Minority Serving Institutions:**

EPA recognizes that it is important to engage all available minds to address the environmental challenges the nation faces. At the same time, EPA seeks to expand the environmental conversation by including members of communities which may have not previously participated

in such dialogues to participate in EPA programs. For this reason, EPA strongly encourages all eligible applicants identified in Section III, including minority serving institutions (MSIs), to apply under this opportunity.

For purposes of this solicitation, the following are considered MSIs.

- 1. Historically Black Colleges and Universities, as defined by the Higher Education Act (20 U.S.C. § 1061). - 3. Hispanic-Serving Institutions (HSIs), as defined by the Higher Education Act (20 U.S.C. § 1101a(a)(5)). HSIs are institutions of higher education that, at the time of application submittal, have an enrollment of undergraduate full-time equivalent students that is at least 25% Hispanic students at the end of the award year immediately preceding the date of application for this grant. - 4. Asian American and Native American Pacific Islander-Serving Institutions; (AANAPISIs), as defined by the Higher Education Act (20 U.S.C. § 1059g(b)(2)). AANAPISIs are institutions of higher education that, at the time of application submittal, have an enrollment of undergraduate students that is not less than 10 % students who are Asian American or Native American Pacific Islander. - 5. Predominately Black Institutions (PBIs), incorporated into the Higher Education Act in 2008 (codified in Section 318(b) of the Higher Education Act of 1965, 20 U.S.C. 1059e.). PBIs are defined as institutions that: serve at least 1,000 undergraduate students; have at least 50% low-income or first-generation degree-seeking undergraduate enrollment; have a low per full-time undergraduate student expenditure in comparison with other institutions offering similar instruction; and, enroll at least 40% African-American students. #### **II. Award Information**

## A. What is the amount of funding available?

The total estimated funding expected to be available for awards under this competitive opportunity is approximately \$100,000.

# **B. Partial Funding Provision**

In appropriate circumstances, EPA reserves the right to partially fund an application by funding discrete portions or phases of proposed projects. If EPA decides to partially fund an application, it will do so in a manner that does not prejudice any applicants or affect the basis upon which the application was evaluated and selected for award, and therefore maintains the integrity of the competition and selection process.

# C. How many agreements will EPA award in this competition?

EPA anticipates award of one to three grants or cooperative agreements under this announcement for the entire available amount of funds available, subject to the availability of funds, quality of evaluated applications, and other applicable considerations. EPA reserves the right to reject all applications and make no awards under this announcement. In addition, EPA reserves the right to make additional awards under this announcement, consistent with Agency policy, if additional funding becomes available after the original selections. Any additional selections for awards will be made no later than six months from the date of the original selections.

## D. What is the project period for awards resulting from this solicitation?

The estimated project period for the award resulting from this solicitation will begin in June 2020. Proposed project periods will be one year.

# E. Funding Type

The funding for the selected project will be in the form of a grant and/or cooperative agreement, as appropriate to the nature of the project proposed.

A grant is an assistance agreement in which the EPA is not substantially involved in carrying out the project.

Cooperative agreements permit substantial involvement between the EPA Project Officer and the selected applicant(s) in the performance of the work supported. The anticipated substantial Federal involvement for this project will be:

- Close monitoring of the successful applicant's performance to verify the results proposed by the applicant;
- Collaboration during performance of the scope of work; and
- Review and comment on reports prepared under the cooperative agreement (the final decision on the content of reports rests with the recipient).

## III. Eligibility Information

# A. Eligible Entities

Consistent with CFDA No. 66.808, the following entities are eligible to compete under this solicitation. States, local, Tribal, interstate, and intrastate government agencies and instrumentalities, and non-profit organizations that are not 501(c)(4) organizations that lobby, including non-profit educational institutions and non-profit hospitals. Individuals and for-profit organizations are not eligible. Non-profit organizations, as defined by 2 CFR Part 200, means any corporation, trust, association, cooperative or other organization that: (1) is operated primarily for scientific, educational, service, charitable or similar purposes in the public interest; (2) is not organized primarily for profit; and (3) uses its net proceeds to maintain, improve and/or expand its operations. Note that 2 CFR Part 200 specifically excludes the following types of organizations from the definition of "non-profit organization" because they are separately defined in the regulation: (i) institutions of higher education; and (ii) state, local and federally recognized Indian tribal governments. While not considered to be a "non-profit organization(s)" as defined by 2 CFR Part 200, Institutions of Higher Education and state, local and federally recognized Indian tribal governments are, nevertheless, eligible to submit applications under this RFA. Hospitals operated by state, tribal, or local governments or that meet the definition of nonprofit at 2 CFR 200.70 are also eligible to apply. For-profit colleges, universities, trade schools, and hospitals are ineligible.

For-profit organizations are not eligible for this funding opportunity. Additionally, non-profit organizations described in Section 501(c)(4) of the Internal Revenue Code that engage in lobbying activities as defined in Section 3 of the Lobbying Disclosure Act of 1995 are not eligible to apply.

## **B.** Cost Sharing or Matching

This competition does not require matching funds or cost sharing.

## C. Threshold Eligibility Criteria

These are requirements that if not met by the time of application submission will result in elimination of the application from consideration for funding. Only applications from eligible entities (see above) that meet all of these criteria will be evaluated against the ranking factors in Section V of this announcement. Applicants deemed ineligible for funding consideration as a result of the threshold eligibility review will be notified within 15 calendar days of the ineligibility determination.

- 1. Applications must substantially comply with the application submission instructions and requirements set forth in Section IV of this announcement or else they will be rejected. Where a page limit is expressed in Section IV with respect to the narrative proposal, pages in excess of the page limitation will not be reviewed.
- 2. In addition, initial applications must be submitted through <a href="https://www.grants.gov">https://www.grants.gov</a> as stated in Section IV of this announcement (except in the limited circumstances where

another mode of submission is specifically allowed for as explained in Section IV) on or before the application submission deadline published in Section IV of this announcement. Applicants are responsible for following the submission instructions in Section IV of this announcement to ensure that their application is timely submitted.

- 3. Applications submitted after the submission deadline will be considered late and deemed ineligible without further consideration unless the applicant can clearly demonstrate that it was late due to EPA mishandling or because of technical problems associated with www.grants.gov or relevant <a href="www.SAM.gov">www.SAM.gov</a> system issues. An applicant's failure to timely submit their application through <a href="www.grants.gov">www.grants.gov</a> because they did not timely or properly register in <a href="www.SAM.gov">www.grants.gov</a> will not be considered an acceptable reason to consider a late submission. Applicants should confirm receipt of their application with Dale Carpenter, <a href="carpenter.dale@epa.gov">carpenter.dale@epa.gov</a>, as soon as possible after the submission deadline—failure to do so may result in your application not being reviewed.
- 4. The applicant must be an eligible entity as described in Section III (A) above.
- 5. Applications must support current administration priorities as described in Section I.C. of this solicitation. These priorities must be explicitly identified.
- 6. All applications must specify and promote the Sustainable Materials Management program priorities described in Section I.A, that is, organics and/or construction and demolition debris, with a priority focus on Puerto Rico and/or the U.S. Virgin Islands.
- 7. All applications submitted under this solicitation must conduct or promote the coordination and acceleration of training, demonstrations, and public education programs relating to the reduction of the amount of solid waste and unsalvageable waste materials as described in Section I. of this announcement.
- 8. Projects that are demonstrations must involve new or experimental methods or approaches, where the results of the project will be disseminated so that others can benefit from the knowledge gained in the demonstration project. A project that is accomplished through the performance of routine, traditional, or established practices, or a project that is simply intended to carry out a task rather than transfer information or advance the state of knowledge, however worthwhile the project might be, is not considered a demonstration project. If a proposal is submitted that includes any ineligible tasks or activities, that portion of the proposal will be ineligible for funding and may, depending on the extent to which it affects the proposal, render the entire proposal ineligible for funding. State clearly how the statutory authority supports your training, demonstration or public education project.

9. Applications are required to benefit Puerto Rico and/or the U.S. Virgin Islands but may also benefit states or communities elsewhere in EPA Region 2 (New York, New Jersey, Puerto Rico, U.S. Virgin Islands).

In the request, the applicant must include the following information:

EPA will only consider alternate submission exception requests based on the two reasons stated above and will timely respond to the request -- all other requests will be denied. If an alternate submission method is approved, the applicant will receive documentation of this approval and further instructions on how to apply under this announcement. Applicants will be required to submit the documentation of approval with any initial application submitted under the alternative method. In addition, any submittal through an alternative method must comply with all applicable requirements and deadlines in the announcement including the submission deadline and requirements regarding proposal content and page limits (although the documentation of approval of an alternate submission method will not count against any page limits).

If an exception is granted, it is valid for submissions to EPA for the remainder of the entire calendar year in which the exception was approved and can be used to justify alternative submission methods for application submissions made through December 31 of the calendar year in which the exception was approved (e.g., if the exception was approved on March 1, 2019, it is valid for any competitive or non-competitive application submission to EPA through December 31, 2019. Applicants need only request an exception once in a calendar year and all exceptions will expire on December 31 of that calendar year. Applicants must request a new exception from required electronic submission through <a href="https://www.grants.gov">https://www.grants.gov</a> for submissions for any succeeding calendar year.
