Drinking Water Regulations 101

Since the 1996 amendments to the Safe Drinking Water Act (SDWA), EPA has issued a number of National Primary Drinking Water Regulations (NPDWRs) that strengthen public health protection. These regulations include those designed to reduce risks from disinfection byproducts; arsenic; surface water pathogens, such as Cryptosporidium; pathogens in groundwater; and water served on board airplanes. To help ensure that drinking water is safe, EPA reviews existing NPDWRs and, as appropriate, revises them to improve public health protection. This presentation will discuss the process included in the SDWA that EPA must follow to develop these regulations.

Leveraging Federal Funds to Build Technical Assistance Programs in the Great Lakes Region

This presentation will describe the breadth and depth of compliance related assistance that the Rural Community Assistance Program (RCAP) provides to small systems, showcasing examples from the seven states within RCAP's Great Lakes Region. She will share Ohio's story where they have leveraged a mix of federal, SRF set-aside dollars, and other state and local dollars to build a large and impactful program. Last year, Ohio RCAP helped over 300 communities building capacity through training, technical assistance, asset management implementation, GIS services, project development and grant writing services. RCAP has played a very important role is extending the SRF program reach to help hundreds of Ohio's small and disadvantaged communities access SRF dollars and other state and federal funding.
