Identify the regulated universe of Lead-Based Paint Renovation, Repair and Painting Rule firms in support of regional targeting strategies, in coordination with the Office of Chemical Safety and Pollution Prevention.	OECA	December 31, 2021	OECA, in coordination with OCSPP, will develop a targeting strategy that will include a geospatial-based model to assist the Regions in identifying "areas of concern for lead exposure in general" along with any guidance on how to identify firms within this area.
2. Establish Lead-Based Paint Renovation, Repair and Painting Rule enforcement objectives, goals and measurable outcomes.	OECA	July 1, 2021	OECA, in collaboration with the EPA Regions, will evaluate the Lead-Based Paint Renovation, Repair and Painting Rule compliance monitoring and enforcement program to determine appropriate refinements to existing program objectives to help OECA set enforcement goals and measurable outcomes for FY21, consistent with the OECA National Program Guidance.

¹ OECA agrees with the OIG that for effective compliance monitoring targeting it is very helpful to know the universe of regulated entities and its details. This is generally noted in the TSCA CMS; however, it may not always be possible to have this detailed universe information for all programs such as the lead-based paint RRP. The universe for the lead-based paint RRP can be best characterized as a transient, unpermitted universe comprised mainly of small businesses. The universe is constantly changing making it virtually impossible to track at any point in time. An effective targeting strategy for a universe of this nature is to identify "areas of concern" then identify potential lead-based paint RRP businesses operating within that area.
