## Landscape Conservation Catalyst Fund

The Conservation Catalyst Fund will distribute funding to landscape conservation partnerships across the United States and offer supplemental

training and mentoring to grantees. The Landscape Conservation Catalyst Fund will focus specifically on building capacity for landscape conservation partnerships by investing in the "backbone" coordination of the collaborative process and in supporting key stepping stone activities necessary to achieve broad-based partnership support and conservation on the ground.

### **Keeping Communities Flowing Grant**

The American Water Charitable Foundation helps empower communities to be strong, vibrant, healthy and environmentally friendly places to live, work and play. Grants support local 501(c)(3) public charities that connect with American Water's core focus areas: Water and the Environment, Water and Healthy Living, Environmental Education, Community Sustainability

### **Partners for Fish and Wildlife**

Wetland and associated upland habitat restoration and enhancement projects for conservation of native Great Lakes fish and wildlife populations, particularly migratory birds and, as appropriate, federally-listed species. Projects will be completed on privately owned lands within the Great Lakes watershed. Emphasis on, but not limited to, watersheds of Great Lakes AOC and in coastal zones.

\*Award ceiling: \$100,000

\*Deadline: September 30, 2019

### **U.S. Fish and Wildlife Service's Coastal Program**
