COVID-19 has pushed us all off course and that goes for all norms for setting federal appropriations. The CARE Act has already allocated \$1.5 billion for the U.S. Economic Development Administration to plan and implement economic recovery strategies in response to the coronavirus pandemic, and other stimulus funding may follow.

This session spotlights federal grants, loans and technical assistance to support brownfield activities throughout all stages of the redevelopment process. We will hear how EPA is working to expand the brownfields redevelopment sandbox by coordinating with other federal agencies. We will also learn what's new with Opportunity Zones and how to layer funding with other federal agencies and programs including EDA, HUD, USDA, USDOT, Community Development Block Grants, and Clean Water Funds.

CommuniTree: A Model for Engaging Communities in Tree Planting and Maintenance Projects

[EPA Children's Healthy Learning Environments Grant Initiative](#)

EPA is seeking grant applications from states, federally recognized tribes, universities, local governments, non-profits, and other groups to support children's environmental health in schools and childcare settings. These grants advance children's environmental health by providing education, training, tools and capacity building.

*EPA anticipates awarding two grants of approximately \$145,000 each for up to a two-year funding period.

The USDA National Agroforestry Center is requesting proposals to substantially expand and accelerate the availability of information to support decisions on the adoption and design of urban agriculture that includes agroforestry practices. The intent of this grant opportunity is to expand the available resources on how urban agriculture systems can include perennials and/or agroforestry practices. Eligible applicants include nonprofit organizations, units of local government, Tribal governments, and any school that serves kindergarten through grade 12.

*Award Range: \$25,000 and \$50,000 with no financial match

EPA will give special consideration to those applications aimed at addressing the impacts of the COVID-19 pandemic communities with EJ concerns.

[Chi-Cal Rivers Fund: 2020 Funding Opportunity](#)

The Chi-Cal Rivers Fund will offer approximately \$1 million in competitive grant funding in 2020. To reduce the overall level of effort required for applicants to be considered for funding, the Fund will eliminate the pre-proposal phase in 2020 and request applicants submit a streamlined full proposal. Grant funding in 2020 will be awarded in three categories:

- Habitat Quality
- Green Stormwater Infrastructure
- Public Access

[NPS Land & Water Conservation Fund Outdoor Recreation Legacy Partnership](#)

Eligible U.S. state and local government agencies and federally recognized Indian tribes are invited to submit proposals for matching grants to support projects that would acquire or develop public land for outdoor recreation purposes located within or serving Census-delineated "urbanized areas": places with a population of 50,000 or more people that are densely settled.

*Award range: \$300,000 to \$1,000,000 with 1:1 match

[2020 National Fish Passage Program](#)

The National Fish Passage Program is a voluntary program that provides direct technical and financial assistance to partners. Activities that restore fish passage also support the modernization of country's infrastructure such as road culverts, bridges and water diversions. Example project types include dam removals, culvert replacements, and the installation of fishways.

*Award range: \$500 - \$2,000,000 with 1:1 match on a regional basis not necessarily project basis

*Applications due: September 30, 2020
