Featured Funding Opportunity IDNR - Lake Michigan Coastal Program Request for Proposals

- *Pre-proposal Deadline: Monday September 16, 2019, 5:00 p.m. CT
- *Maximum request: Depending on project category from \$50,000 to \$150,000
- *Non-federal match: 50% of the total cost of the project.
- *Project Period: Beginning no earlier than August 1, 2020 and less than 18 months in duration.

The purpose of Lake Michigan Coastal Program Grants Program is to supportprojects that seek to improve the connection between the public and communities and the natural, cultural, and/or historical resources of Indiana's Lake Michigan watershed as well as projects that assist communities and

organizations in the coordination and planning for the management or restoration of these resources in the coastal area. Proposed projects must fall under one of six categories:

Education & Outreach,

- Planning/Coordination/Management,
- Low Cost Construction,
- Land Acquisition,
- · Applied Research, or
- · Emerging Issues.

Funding Opportunities

New EPA GLRI funding for trash-free water projects in the Great Lakes

EPA expects to issue a Request for Applications (RFA) in October to solicit applications from eligible entities for GLRI grants. Once the RFA is released, applicants will have approximately 45 days to respond to the RFA. EPA anticipates that approximately \$2 million in total funding will be available, with a maximum grant amount of \$500,000 per project. Up to 12 grants could be awarded, including two larger scale projects and 10 smaller scale projects. For more information, read the press release.

Partners for Places Grants

Partners for Places is a matching grant program that enhances local capacity to build equitable and sustainable communities in the United States and Canada. The fund does this by requiring local government and local foundation partnerships, and by pairing national and local philanthropic funding sources. The one-to-one matching awards support the planning and implementing of urban sustainability and green stormwater infrastructure projects.

*Applications due July 30, 2019

*Award range typically \$25,000 - \$100,000 with 1:1 match

Groundwork USA-Technical Assistance

Groundwork USA, in partnership with NPS and EPA, is accepting letters of interest from communities wishing to apply for Groundwork USA program funding and technical assistance. The selected community will be eligible for up to \$200,000 in funding and technical assistance to plan, establish and build the capacity of a Groundwork Trust organization in their community.

Great Lakes Emerging Champions Mini-Grant Program

Great Lakes Emerging Champions Mini-Grants are intended to increase green infrastructure (GI) implementation capacity in small to mid-sized communities in the Great Lakes Basin. Grants support community projects that focus on developing strategies to overcome key institutional barriers to implementing GI in communities.

The Northwest Indiana Urban Waters Partnership focuses on the Lake Michigan watershed in Lake, LaPorte and Porter Counties, Indiana.

Urban Waters works to connect urban communities, particularly those that are overburdened or economically distressed, with their waterways by improving coordination among federal agencies and state and local partners. The goals are to improve the Nation's water systems and to promote their economic, environmental and social benefits.
