

# Public Notice: MAX Environmental Technologies, Inc. - Yukon, PA

**DATE OF THIS NOTICE:** 8/26/2020

**PURPOSE OF THIS NOTICE:** The US Environmental Protection Agency is announcing the issuance of a Statement of Basis and draft Corrective Action Permit for proposed remediation at the MAX Environmental Technologies, Inc., Yukon facility.

**Summary of Proposed Action:**

RCRA Corrective Action - Cleanup Proposal and Draft Permit

**FACILITY DESCRIPTION:** The Facility is located approximately 30 miles southeast of Pittsburgh, PA, in South Huntingdon Township, Westmoreland County, Pennsylvania. It is a treatment facility for residual and hazardous waste, and a disposal facility for residual waste. Waste operations are permitted on 137 acres of the Facility.

EPA's proposed remedy for the Facility areas consists of:

- 1) continued compliance with Pennsylvania Hazardous Waste Permit and Solid Waste Permit, and
- 2) additional monitoring of residential wells adjacent to the Facility.

**COMMENT PROCESS:** Persons to comment on EPA's proposed decision must submit comments to EPA within the 45-day comment period ending **10/10/2020**. Interested persons may also request a public hearing on this proposed remedy. All comments and/or requests for a hearing must be submitted in writing via mail, fax, or email to the EPA Project Manager, Paul Gotthold as listed above, and must be received prior to **10/10/2020**. All comments will be considered in making a final decision.

**FINAL DECISION:** EPA will make a final decision after considering all comments, consistent with applicable RCRA requirements and regulations. If the remedy is substantially unchanged from the one in this notice, EPA will issue a final decision and inform all persons who submitted written comments or requested notice of EPA's final determination. If the remedy is significantly different from the one proposed, EPA will issue a public notice explaining the new remedy and will reopen the comment period.
