## EPA PUBLIC NOTICE

Underground Injection Control (UIC) Program Notice of Proposed Permit Issuance for Pennhills Resources, LLC

The U. S. Environmental Protection Agency, Region 3 (EPA) is issuing a proposed permit under the authority of the federal Underground Injection Control (UIC) regulations at 40 Code of Federal Regulations (C.F.R.) Parts 124, 144, 146, and 147 to Pennhills Resources, LLC.

**Description:** Pennhills applied for one (1) UIC Class II enhanced recovery injection well permit, to be used for the injection of produced fluids through three (3) injection wells to enhance the recovery of oil. The injection wells are located in the Allegheny National Forest, Wetmore Township, McKean County, Pennsylvania. The draft permit will allow Pennhills to inject produced fluids into the Haskell Sandstone formation at depths of approximately 2,410 feet. If the final permit is issued to Pennhills, it will remain in effect for the operational life of the facility. A permit is required to meet the provisions of the EPA-administered UIC Program in Pennsylvania.

**Tentative Public Hearing:** EPA has tentatively scheduled a virtual public hearing on September 15, 2020. An in-person hearing will not take place. The call-in information for the teleconference is listed below:

The virtual hearing is an audio-only teleconference. Participants who want to supply written or printed materials, should do so via email.

EPA expressly reserves the right to cancel this hearing unless a significant degree of public interest is evidenced by September 8, 2020.
