Re: Underground Injection Control (UIC) Permit WY20654-03747, Construction Change, SA Tribal 44 Well, Draft Major Permit Modification, Fremont County, Wyoming

Dear Mr. Kerr:

The U.S. Environmental Protection Agency Region 8 has reviewed your June 19, 2020, request for a well construction change for the UIC Permit and well listed above.

Wesco Operating Inc., operator of the SA Tribal #44 (also known as the Lander Phosphoria #44) injection well, requests modification of the permitted injection well construction for the SA Tribal #44, EPA Permit number WY20654-03747, API # 49-013-05881. This well lost mechanical integrity and was reported to EPA on May 22, 2020.

Enclosed is the draft UIC major permit modification to incorporate an addition of a liner casing and reduction in tubing size in the well's construction which are presented in Appendix A of the referenced UIC Permit. These construction changes will also result in changes to Permit conditions in Part II. Section A. paragraphs 1 and 2, of the original permit as well. The casing liner will be installed to isolate a leak in the long string casing. The addition of the liner will result in a reduction in the injection tubing size. Wesco will need to run a Part I (Internal) Mechanical Integrity Test, Cement Bond Log, and Step Rate Test following well completion activities and prior to receiving authorization to recommence injection on the SA Tribal #44 well as identified in Appendix B of the permit. An updated Rework Form 7520-19 must be submitted following the completion of well re-construction activities. Also, the responsible party for the well operations and adherence to the permit conditions is changed from Amoco Production Company to Wesco Operating, Inc.

EPA regulations and procedures for issuing UIC permit decisions are found in Title 40 of the Code of Federal Regulations (40 CFR) part 124. These regulations and procedures require a public notice and the opportunity for the public to comment on this proposed permit decision. The public comment period will run for at least 30 days and a courtesy announcement of the comment period will be published in the following newspaper:

The Riverton Ranger, Riverton, Wyoming

A final decision will not be made until after the close of the comment period. All relevant comments will be taken into consideration. If any substantial comments are received, the effective date of the final Permit will be delayed for an additional 30 days, as required by 40 CFR § 124.15(b), to allow for any potential appeal of the final permit decision.

EPA regulations and procedures for modification of UIC Permits are found in Title 40 of the Code of Federal Regulations, Sections 124.5 and 144.39. These regulations and procedures require a 30-day public notice period.
