Pull packer and re-run tubing string to TD

Spot plug #1: 176 sx class A cement from 7388-5000'

Stand back tubing

Cut 4 1/2 casing at 5000' and gel hole

Lay down 4 1/2 casing

Run tubing 3300' and spot the following cement plugs with 6% gel plugs between each cement plug

Plug #2: 29 sx of cement from 3300-3200'

Plug #3: 29 sx of cement from 3000-2900

Plug #4: 29 sx of cement from 2600-2500

Plug #5: 60 sx of cement from 1050-950

Bail 8 5/8 casing from 950-surface

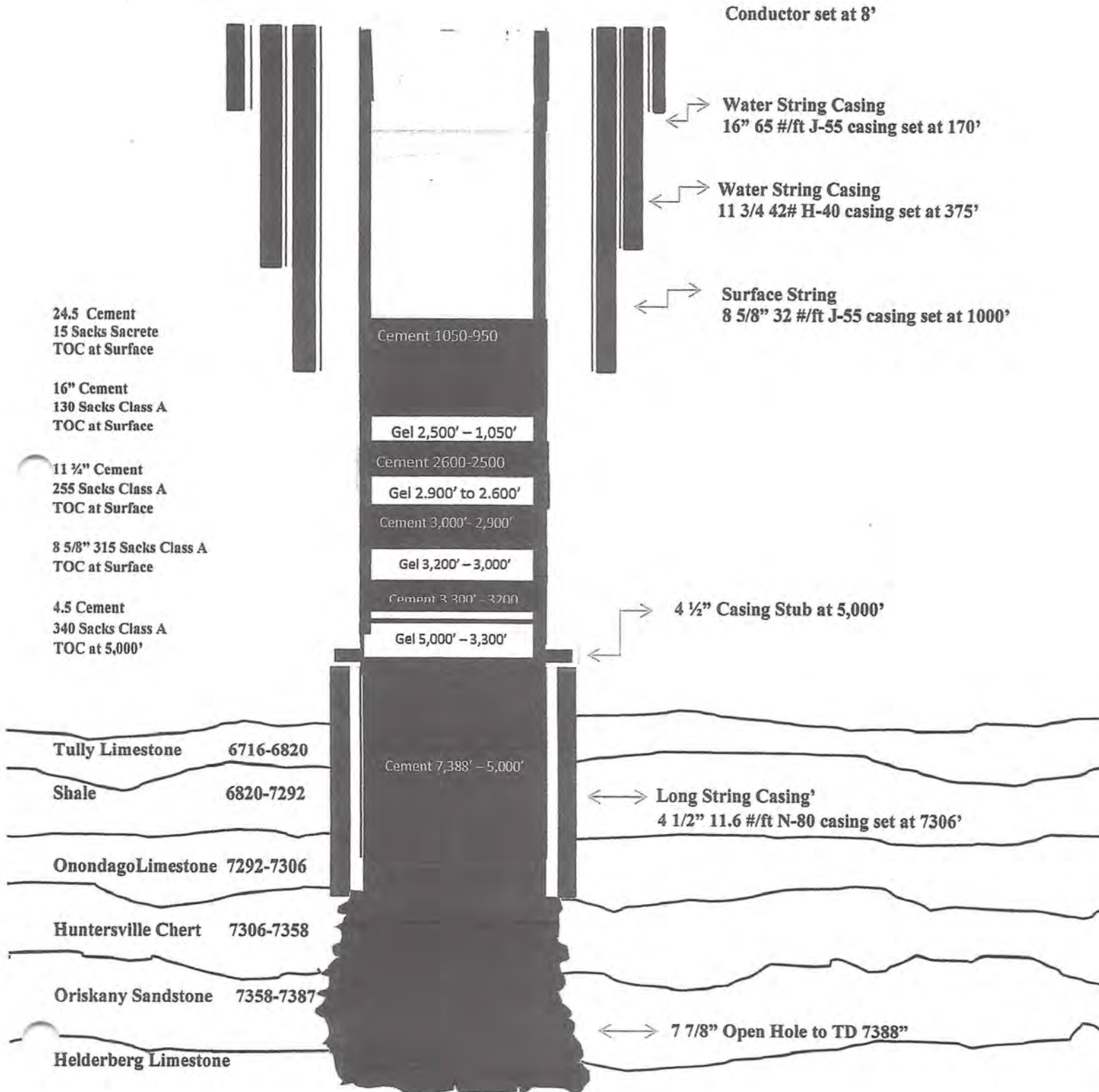
