Dear Ms. Justus:

Enclosed is your copy of the final U.S. Environmental Protection Agency Region 8 Underground Injection Control Program (UIC) permit (Permit) for the above referenced well or project area.

The public comment period ended on August 17, 2020. We received comments on the draft Permit during the public notice period. Also included with this letter is a copy of the response to comments that documents changes to the final Permit. Because comments were received during the public comment period, the final Permit becomes effective 30 days from the date of issuance per Title 40 Code of Federal Regulations (40 CFR) § 124.18, to provide a 30-day window for the commenter(s) to appeal the final Permit decision. All conditions set forth herein refer to 40 CFR parts 124, 144, 146, and 147 and are regulations that are in effect on the date that this Permit becomes effective.

Please note that under the terms and conditions of this final Permit you are only authorized to construct the proposed injection well. Prior to commencing injection, you first must fulfill all requirements prior to commencing injection found in the final Permit, Part II Section B.2, and obtain written authorization to inject from EPA. It is your responsibility to be familiar with, and to comply with, all provisions of your final Permit.
