Summary of Proposed Action:

The United States Environmental Protection Agency (EPA) is extending the comment period for its proposed remedy for the MAX Environmental Technologies, Inc., Yukon facility (Facility) until November 19, 2020. Originally, the EPA announced its proposed remedy for the Facility on August 26, 2020, with the original comment period closing October 10, 2020. Today's public notice extends the comment period until November 19, 2020. EPA will also hold a virtual public informational meeting on November 10, 2020 at 7pm EST for the Facility. The meeting will cover the proposed remediation outlined in the Statement of Basis and draft Corrective Action Permit, issued by EPA on August 18, 2020.
