

ATTENTION CEDRI USERS: Recent Updates in CEDRI

EPA's Compliance and Emissions Data Reporting Interface (CEDRI) is now providing monthly updates to all active CEDRI roles via email. CEDRI has recently implemented new/updated reports, job aides, and enhancements that are summarized below:

Following report updated in CEDRI

- Metal Coil (63, subpart SSSS) 63.5181(c) Semiannual Compliance Report (Version 1.00) template is now available in CEDRI. (October 22, 2020)
- Surface Coating of Wood Building Products (63, subpart QQQQ) 63.4720 Semiannual Compliance Report (Version 2.00) template updated in CEDRI. Users will need to download and use the version 2.00 template for future submissions. (October 19, 2020)
- Industrial, Commercial, and Institutional Boilers Area Sources (subpart JJJJJ) 63.11225(a)(4)(vi) Notification of Compliance Status (Version 2.00) template updated in CEDRI (October 14, 2020). Users will need to download and use the version 2.00 template for future submissions.
- All Part 63 subparts now include two new Reclassification of Major Sources as Area Sources Under Section 112 of the Clean Air Act (MM2A) reports for industry to use (October 9, 2020):
 - 63.9(b) Initial notifications for an area source reclassifying to major source who had previously been subject to major source rule (a major to area back to major transition)
 - 63.9(j) Change in information already provided (required for major source to area source reclassification)
- Site Remediation (63, subpart GGGGGG) 63.7951(f) Semi-Annual Compliance Report (Version 2.04) template updated in CEDRI (October 8, 2020)

Other CEDRI Enhancements and Updates

- As part of the CEDRI 2020 update, version 1.00 of the periodic reporting template for the Petroleum Refinery Fenceline Monitoring Report (40 CFR 63.655(h)(8)) will be replaced with version 2.00. The version 2.00 template version is available in the Part 63 Rules and Required Reports Available in CEDRI table found below. The new template version will be required starting with the first quarter 2021 reporting period (the report due on May 15, 2021), but you may begin using it immediately. Prior to submitting the first quarter 2021 report, users will need to download and use the new template version 2.00 in order to successfully submit the report in CEDRI.
- Enhancements: Added new filters for CEDRI History table: CROMERR Document ID, CROMERR Activity ID, and County; Add Download Link to CEDRI History Excel Export that Downloads All Report Documents (for downloads of 10 or less records) (October 9, 2020)
- CEDRI 2020: EPA has removed access to webforms for several periodic reports; users will need to access the appropriate Excel spreadsheet for reporting (September 25, 2020)

Updated or New Job Aides

- New Job Aide has been implemented: CEDRI Error Messages (Version 1.00) for industry and reviewer roles (November 6, 2020)
- CEDRI Report Details Job Aide has been updated for Industry users. (September 25, 2020)

Notes:

1. Please note the report template version provides the periodic report template version (found on the Welcome tab) accepted in CEDRI. If a periodic report template has a version number listed

as 1.XX for a given periodic report (e.g., Annual Report), any version template in the Version 1 series (e.g., 1.01, 1.02, 1.03) would be accepted in CEDRI. **A user will only have to download and use a new reporting template when there is an incremental change in the whole number of the version number, e.g., from 1.00 to 2.00.**
