Tips: Submitting Official Comments on Proposed § 608 Amendments

- ► This is the standard list of recommendations from EPA on submitting comments to proposals and rules
 - ▶ Submit your comments by the deadline: Feb 14, 2011 at 11:59 pm!
 - Explain why you agree or disagree with specific aspects of the proposal (not just "I don't like it)
 - Suggest alternatives and specific changes to text that correspond to your requests
 - Describe any assumptions and provide any technical information and/or data that you used in preparing your comments
 - ► If you estimate potential costs or burdens, explain how you arrived at your estimate in sufficient detail to allow for it to be reproduced
 - Provide specific examples to illustrate your concerns, & suggest alternatives
 - Explain your views as clearly as possible
 - ► Avoiding the use of profanity or personal threats
 - ► If commenting by fax, email, or by [snail] mail, make sure you identify the proposed amendments by docket number and other identifying information (subject heading, Federal Register date, and page number)
 - ► Please give us feedback on the specific questions that EPA asked in the text of the proposal
 - ▶ If commenting on specific text, reference the specific part or section of the proposal

Submit Official Comments on Proposed Section 608 Amendments

- ▶ Go to http://www.regulations.gov
- ▶ Towards the top of the page, in the drop-down box titled "Select Document Type," select "Proposed Rule"
- Next to that, in the box titled "Enter Keyword or ID:" type "EPA-HQ-OAR-2003-0167"
- ► Click "Search" (you will be taken to a new page with your search results: "Protection of Stratospheric Ozone: Amendments to the Section 608 Leak Repair Requirements")
- In the box with your search results, click on the title of the proposed rule "Protection of Stratospheric Ozone: Amendments to the Section 608 Leak Repair Requirements"
- ► This leads to a new page w/details of the proposal. At the top right of the screen, click the orange box that says "submit a comment"
- ► Fill in your comments (note that additional files and attachments can be uploaded to accompany your comment)
- Press "Submit" (in the orange box towards the bottom of your screen)
