

Introduction

The Environmental Protection Agency (EPA), Region III hosted the second Beyond Translation Forum (BTF) on April 6, 2010. The event was co-sponsored with Temple University and the Pennsylvania Horticultural Society. The BTF is an annual event that seeks to engage the local Asian and Hispanic communities in a meaningful dialogue on the environmental issues and concerns they may be facing. The forum is part of the National Beyond Translation Initiative, which main purpose is to expand the conversation on environmentalism by developing working partnerships with these communities.

Hispanics and Asians have grown increasingly concerned and are disproportionately affected by environmental issues. It is crucial to welcome new advocates that strive to protect their communities' health and environment and that voice their communities' issues and concerns in the mainstream discussions we're having on environmental action. In addressing their concerns and providing information on resources that are available to them, inside and outside of the Agency, EPA is better reflecting the needs of the communities we serve.

The theme for this year's forum was Building a Healthy & Sustainable Community Today. The forum engaged our Asian and Hispanic communities in the sustainability dialogue, particularly in light of Philadelphia's recently launched Greenworks Philadelphia campaign. Invited participants included community leaders, non-profit organizations, city representatives and students from local colleges and universities.



Summary of Presentations

The one-day forum consisted of a general morning session and two concurrent afternoon breakout sessions. The morning session began with welcoming remarks from Sandra McDade, Director of Temple University's Office of Sustainability. Opening remarks were provided by EPA Region III Deputy Regional Administrator Bill Early. Mr. Early emphasized that one of the Agency's top priorities is to expand the conversation on environmentalism and environmental justice, including traditionally underrepresented groups in the environmental dialogue. He encouraged the Asian and Hispanic communities to participate in the conversation early on in the process, to be a part of moving forward in planning a sustainable future.

The keynote speaker was Sandra Dungee Glenn, President of American Cities Foundation (ACF). Ms. Glenn spoke on the importance of environmental activism, public health and the need for green, community-based jobs. She provided an overview of ACF's programs, which work to improve the quality of life for children, youth and families through systematic change. The programs are designed to revitalize urban communities using sustainable practices in developing youth and adult workforces, small businesses, and environmental conservation.

The morning session also included a panel discussion on Building a Sustainable Philadelphia. Panelists included Kristin Sullivan, a project director within the Philadelphia Mayor's Office of Sustainability; Brendan Shane, Director of the Office of Policy and Sustainability in the District Department of the Environment (DDOE); and Todd Baylson, from the Pennsylvania Horticultural Society (PHS). Ms. Sullivan provided an overview of the Greenworks Philadelphia plan, which aims to make Philadelphia the 'greenest city in America', by promoting sustainability in five ways: energy, environment, equity, economy, and engagement. Brendan Shane offered insight in how the District of Columbia (DC), a neighboring city, has approached building a sustainable city. Mr. Shane discussed the various projects that are underway in implementing the Green DC Agenda, including green building and infrastructure, renewable energy, waste reduction and recycling, green economy, transportation, and outreach. Todd Baylson provided a local perspective on developing a green city, and presented PHS' work with Philadelphia communities in improving quality of life through promoting green and sustainable practices.

Lessons Learned

Separate evaluations were performed by forum participants and planning committee members in order to obtain feedback on the information shared at the forum and to identify additional needs and concerns. The main issues identified by the evaluation include the following:

- **Presentation level**

The language used by presenters often consisted of governmental jargon that was not self-explanatory to the audience. The planning committee held several conference calls with the presenters communicating the need for using layman's terms during their presentations, which proved to be very difficult for some of them. Perhaps, in future preparation for an event, it would be appropriate to request presentation materials ahead of time for review.

- **Selection of presenters**

Although there were no negative remarks about any particular presenter, it is evident that the breakout sessions should focus more on community work rather than governmental procedures (e.g., grant application process). The audience may relate better with actual projects performed by community members similar to them. Learning government procedures is still essential for community-based organizations; however, it may be more effective to address this topic through individual focused workshops.

- **Asian community representation**

The planning committee worked diligently to engage participation from local Asian communities in the months leading up to the forum. Nevertheless, participation from the Asian community in the forum was low. Because of intrinsic cultural differences between ethnic communities, it is critical to identify the best approach to engage each of them in the environmental conversation. The planning committee is currently re-evaluating our approach in an effort to increase the various Asian communities' involvement.

- **Beyond Translation as an initiative**

Beyond Translation is intended to be an on-going initiative, not just an annual event. Maintaining an active level of effort is vital to sustain and improve EPA's relationship with our communities and stakeholders.

Region III Beyond Translation Initiative-Future Work

The following work is either under way or proposed for the near future:

- **2010 Student Career Employment Program** – Students are working on improving our current Beyond Translation website, to include information and resource needs for our communities and stakeholders.
- **Beyond Translation Initiative National Program** – Possibility of partnering with the National Beyond Translation team to coordinate a Washington, D.C. Beyond Translation Forum using the Philadelphia BTF as a model.
- **2011 Philadelphia BTF** – Start the planning process for the 2011 Philadelphia BTF.

Sandra Dungee Glenn, President & Chief Executive Officer, *American Cities Foundation*

Sandra Dungee Glenn's career spans over 30 years in public policy, electoral politics and community organizing. She has been actively involved in public education for a decade. She co-founded the Pennsylvania Campaign for Public Education, was appointed to the Board of Education for the School District of Philadelphia, and served as a Commissioner on the School Reform Commission (SRC). In September 2007, Pennsylvania Governor Edward Rendell appointed Ms. Dungee Glenn to the position of Chairwoman of the SRC and then to the Pennsylvania State Board of Education in 2009.

Ms. Dungee Glenn graduated from Pennsylvania State University in 1978 with a Bachelor of Science degree.
