Asthma Awareness Workshop:

May is Asthma Awareness Month and we are joining thousands of organizations to increase public awareness of the asthma epidemic and to provide information that can be used to take action to help get asthma under control in communities across the nation. Asthma affects almost 25 million people of all ages and races and, though asthma is widespread, public awareness of common asthma triggers and effective asthma management strategies remains limited. The purpose of this workshop is to assist school nurses and other health care professionals in the recognition, prevention and treatment of asthma.



Green and Healthy Schools Workshop:

The Green and Healthy Schools workshop and Fair, which was originally scheduled for April 11, 2011, has been re-scheduled to coincide with the Asthma Awareness Workshop. The purpose of this workshop is to help promote green and healthy school environments for all school children and staff. The workshop will include presentations by experts on emerging school environmental health topics. Our target audience is school district personnel, facility managers, school administrators, school nurses, State and local personnel, nonprofit organizations, PTAs/PTOs, parents, teachers, school children, and others interested in creating green and healthy school environments for children.

In addition to presentations by experts on emerging school environmental health topics, we will have a room with informational booths with lots of outreach materials, interactive learning activities, a room for video viewing, and a special appearance by our EPA frog.
