

**Notice of proposed Settlement of Safe Drinking Water Act
Administrative Penalty and Opportunity to Comment in Matter of
Costco, Inc.**

**In the Matter of Costco Wholesale Corporation,

EPA is authorized under Sections 1423(c) and 1445(a) of the Safe Drinking Water Act (the "Act"), 42 U.S.C. Parts 300h-2(c), 300j-4(a), to assess administrative penalties against any person who fails to comply with the requirements of regulations enacted in accordance with Section 1422(c) of the Act, 42 U.S.C. Part 300h-1(c). This action under Section 1423(c) is conducted in accordance with "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties, Issuance of Compliance or Corrective Action Orders, and the Revocation, Termination or Suspension of Permits" ("Consolidated Rules"), set forth at 40 C.F.R. Part 22.

Costco Wholesale Corporation ("Respondent") agrees to the issuance of this Consent Agreement and proposed Final Order ("settlement"). In accordance with Section 1423(c)(3)(B) of the Act, 42 U.S.C. Parts 300h-2(c)(3)(B), EPA is hereby providing public notice of and opportunity to comment on this proposed settlement, recorded in a Consent Agreement and proposed Final Order in the following matter:

Description of Business or Activity Conducted by the Respondent:
Wholesale warehouse

Alleged Violation: Costco Wholesale Corporation ("Costco") is allowed to engage in underground injection pursuant to the Underground Injection Control Regulations of 40 C.F.R. Parts 124, 144, 145, 146, 147 and 148. In the consent agreement, EPA alleges that Costco failed to close its three large capacity cesspools and is in violation of the large cesspool ban that took effect on April 5, 2005.

Proposed Settlement Penalty: \$75,000

If the 30th day of the comment period falls on a Saturday, Sunday or federal holiday, the deadline shall be extended to the next business day. See 40 C.F.R. 22.7(a). In order to provide opportunity for public comment and in accordance with 40 C.F.R. 22.45(b), EPA will not take final action in this proceeding prior to forty (40) days after issuance of this notice.
