Tribal Program Office Staffing Update

- EPA Region IX is finalizing a "Resource Guide for Tribal Governments & Tribal Communities: Preventing Childhood Lead Poisoning in Indian Country." The guide contains information on preventing childhood lead poisoning, federal agency grant funding opportunities, regulatory requirements on lead-based paint and lead hazards, and related information. Air Division

Ozone Standard

- EPA is currently reconsidering the 2008 Ozone standard.

- The new standard was proposed in January 2010, with a range of 0.060 to 0.070 parts per million (ppm) 8-hr primary standard (to protect human health); and a range of 7 to 15 ppm-hours secondary standard (to protect wildlife and vegetation).
- Final standard Fall 2010.

Pinal County, AZ Designation/Redesignation

- EPA is working to designate Pinal County, Arizona, as non-attainment for PM10 and PM2.5. Tribal lands might be included in the non-attainment area.
- The majority of tribal lands will be deferred due to ongoing consultation with the impacted tribes.

Best Available Retrofit Technology (BART) Federal Implementation Plans (FIPs) for Power Plants on Navajo Nation

- EPA promulgates FIPs in tribal jurisdictional areas as necessary to protect air quality. BART provisions of the Regional Haze Rule require reductions in the emissions of air pollutants that impact visibility.
- There are two Regional Haze BART-eligible sources on the Navajo Nation: Navajo Generating Station (NGS) and Four Corners Power Plan (FCPP).
- August 2009 - EPA issued the Advanced Notice of Proposed Rulemaking (ANPRM) to seek public input on two factors for NGS and FCPP - cost effectiveness and visibility benefits.
- FCPP rulemaking proposed October 6, 2010, 60 day public comment period and public hearings.
- Proposed rulemaking on NGS anticipated spring 2011.

Diesel Emission Reduction Act (DERA) Request for Proposals (RFP)

- RFP for FY11 DERA funding expected November 2010, \$60 million will be available nationally.

- Funding will be set aside for tribal projects, and tribes will be able to apply for smaller projects (\$30K funding threshold for tribes vs. \$300K for other applicants). Tribal applications will be evaluated against each other by EPA HQ.

Tribal Office staff updates:

Vanegas will be responsible for Clean Water Act grants for Tribes in Arizona and Southern California in addition to co-leading the Clean Water Act Indian Set-Aside grant program.

Lopez will be responsible for Clean Water Act grants for Tribes in Arizona, Clean Water Act Indian Set-Aside grants and Tribal Border Infrastructure Interagency Agreements with the Indian Health Service for Tribes throughout the Region.

Clean Water Act (CWA) Section 106 Water Pollution Control Grant Program for Tribes:

Purpose:

The Water Pollution Control Program assists Federally-recognized Indian Tribes with achieving environmental results by developing institutional capacity for administering water quality programs to protect, improve, and enhance natural resources.

Eligibility: Tribes must have CWA 106 Financial Assistance Eligibility in order to receive CWA 106 funding. First time applicants must submit a complete (FAE) application by January 14, 2011. Please contact Danielle Angeles (415) 972-3441 or angeles.danielle@epa.gov if interested.

Deadline: Draft proposals due to WTR-10 Project Officers on February 1, 2011.

Clean Water Act (CWA) Section 319 Nonpoint Source Pollution Control Grant Program for Tribes – BASE Funding*

Purpose:

The Nonpoint Source Pollution Control Program assists Federally-recognized Indian Tribes develop and implement polluted runoff control programs and watershed based plans that address critical water quality concerns and achieve positive environmental results.

Base Funding Allocation:

- \$30,000 for Tribes with 1,000 square miles or less.
- \$50,000 for Tribes with more than 1,000 square miles.

Deadline for BASE funding only: Proposed work plan and budget due to your Clean Water Act Grants Project Officer by March 1, 2011.

Region 9 Pilot: Water Quality Assessment Report Template Version 2010

The Water Quality Assessment Report (WQAR) template, Version 2010 was released to Region 9 Tribes on September 13, 2010. The template was originally developed and released last year by EPA Region 9 and the RTOC Clean Water Act Work group as a mechanism to describe water quality in Region 9 Indian Country.

The Region 9 Pilot WQAR Template: Version 2010, accompanied with the Narrative (Tab 5) and water quality data in WQX / STORET format will satisfy the annual reporting requirement for receiving CWA Section 106 funding. Tribes participating in the CWA 106 program are asked to please return the *completed* template to your CWA 106 Project Officer no later than **Wednesday, February 2, 2011**. Drinking Water Tribal Set-Aside Funds

Overview:

EPA Region 9 is pleased to issue the 2011 guidance and procedures for applying for assistance from the Drinking Water Tribal Set-Aside (DWTSA) program. This program provides funding for tribes within Region 9 (California, Nevada, and Arizona) for public drinking water system infrastructure. Funds are awarded through direct grants to tribes or interagency agreements with the Indian Health Service. The funding will be used to address the most significant public health threats for public water systems.

Up to \$6 million of FY 11 funds may be available. In addition, projects ranking higher than Health Category K may be considered under the anticipated FY12 appropriation. Matching funds are not required; however, in cases where commercial entities and/or non-tribal populations receive water from the public water system, EPA may ask the tribe to provide a matching contribution.

Important Date: November 5, 2010: *EPA must receive proposals by this date, including 3 copies of the proposal form, tribal government endorsement, and any preliminary feasibility studies and supporting documents. Proposals received after November 5, 2010 will not be considered for funding.*

Free Waste Characterization Audit Trainings. We are looking for three to four Tribes to host this training. A free waste characterization audit will be conducted for the hosting Tribe.

Criteria for Hosting Audit Training:

- The tribal facility has adequate space to safely conduct the waste audit with up to 20 people participating (neighboring tribes will be invited to participate);
- There is sufficient solid waste to conduct a waste characterization audit (at least 2,000 lbs);
- The Tribe has staff to assist in coordinating the training with U.S. EPA and waste hauler (if applicable);
- The tribe can provide 18 months of solid waste generation and disposal data (volume, weight, cost/ton) and any past solid waste studies. (*Ideal, not required*)
- The Tribe agrees to share environmental results for public educational and outreach purposes.
