## **Air Division Update**

### Tribal Air Funding

- Region 9 received 36 applications for FY 11 tribal Clean Air Act (CAA) funding.
  - We are evaluating the applications and will notify tribes of their funding status by the end of April.

## Pinal Particulate Matter Redesignation (PM10 and PM2.5)

- R9 is working to redesignate Pinal County for PM10 & PM2.5.
  - Pinal County has violated the PM10 standard since 2002, and the PM2.5 standard in 2006.
- If Pinal is designated nonattainment, Pinal and ADEQ will need to develop a state implementation plan (SIP).
  - Several tribes in Pinal County will be impacted by this action.
  - Region 9 will consult with the impacted tribes before finalizing the designation boundaries.

#### New Ozone (O3) Standard

- On January 6, 2010 EPA proposed to strengthen the Ozone standard.
  - Proposed primary standard: .060-.070 ppm
  - Proposed secondary standard: 7-15 ppm-hours
  - 2008 standard was .075 ppm primary and secondary
- Several tribes in Region 9 submitted comments by the March 22, 2010 deadline.
- Many Region 9 tribes may be impacted.
- ▶ EPA will issue final standards by August 31, 2010.
- Attainment and nonattainment recommendations from Tribes and States on the new standard will be due January 2011.
- Designations process will be completed by August 2011.

#### **BART Determination for Navajo Power Plants**

- ▶ EPA is responsible for determining the Best Available Retrofit Technology (BART) for two coal-fired power plants on Navajo Nation.
- In August 2009, EPA issued an Advanced Notice of Proposed Rulemaking requesting public comment on visibility improvements and cost effectiveness.
- ▶ EPA is aware of the concerns of many Arizona tribes related to the Central Arizona Project and has consulted with Navajo Nation, the Hopi Tribe, Ak-Chin Indian Community, and Gila River Indian Community.
- Consultation is pending with Pascua Yaqui, Fort McDowell, and Tohono O'odham.
- BART proposals published in summer 2010 (anticipated).
  - There will be a lengthy public comment period, public hearings, and public information meetings.

#### New Air Toxics Requirements

- EPA is required to develop air toxics regulations for 70 categories of area sources.
- ▶ 66 rules have been issued to date
  - 47 of those have been issued just since 2006.
  - The remaining 4 will be issued by the end of 2010
- Sources must comply within 3 years of rule issuance

#### Tribal Travel Fund (TTF)


- The travel fund can support travel to RTOC meetings and training.

## Lead Program – Renovation, Repair & Painting Rule

Toxics Substances Control Act Section 402(c)(3)

Beginning 4/22/2010, new Rule applies to any contractor compensated for renovation, repair or painting activities at pre-1978 housing or child occupied facilities must be trained/certified in lead-safe work practices.

Rule applies to builders/painters/ plumbers/ electricians or any business receiving compensation for renovation work (such as hardware stores that sub-contract work).

Rule applies where > 6 sq. feet of lead-based paint disturbed in room or > 20 sq. feet disturbed on exterior.





#### Lead Program - Renovation, Repair, & **Painting Rule**


#### Trained contractors must:

- post warning signs;
- restrict occupants from work areas;
- contain work areas to prevent dust & debris from spreading;
- provide on-site training in lead-safe work practices to uncertified workers (only one worker per site needs to be certified);
- conduct thorough cleanup & verify that cleanup was effective;
- keep required records.

Program delegation to Tribes is possible.

#### New Enforcement Response Policy for Public Drinking Water Systems

- Announced by OECA AA, Cynthia Giles, on 12/9/2009
- Focuses on PWSS with the most significant violations
- Enforcement Targeting Tool scores based on system-wide assessment of violations
- Goal is Return to Compliance
- More protective of public health
- Provides additional tool for identifying systems possibly in need of additional help in Capacity Development and Sustainability
- Seeking input from Tribes on how to best approach implementation of the Policy

## Superfund Division

### Superfund Activities

- Elem Tribal and Sulphur Bank Mercury Mine Removal Action – EPA is completing the capping of a road contaminated with mercury and arsenic.
- ▶ Tohono O'odham Nation EPA and the Tribe commented on work plan documents for the Cypress Mine groundwater RI/FS.

### Superfund Activities

- Navajo Nation EPA is completing an Interim Removal Action: 100,000 cubic yards of radium contaminated soil have been scraped from residential areas and consolidated in the North East Church Rock (NECR) mining site. Reseeding and fencing of the scraped area will be completed in May, 2010. In addition:
  - Completed 192 on-site screenings of Abandoned Uranium Mines
  - Completed removal assessments for the Skyline Mine and NECR Mine.
