  - Feasibility studies to determine the technical and economic viability of a future renewable project (Topic Area 1)
  - Development (pre-construction) activities leading to the deployment of renewable energy projects (Topic Area 2)
  - Deployment (construction) of renewable energy projects for power production (Topic Area 3).

# Registration and Application Submission Requirements IMPORTANT!


- Allow at least 21 days to complete registrations. To submit an application under this announcement, complete the following requirements:
- Obtain a Dun and Bradstreet Data Universal Numbering System (DUNS) number on the Dun and Bradstreet Web site.
- Register in the Central Contractor Registration (CCR) system.
   Designating an E-Business Point of Contact (EBiz POC) and obtaining a special password called an MPIN are important steps in CCR registration. These items are needed to submit applications in Grants.gov. Update your CCR registration annually.
- Register in Grants.gov. For more information, see the Organization Registration User Guide and the Applicant User Guide.
- Register in FedConnect using the "Register as a Vendor" link. To create an organization account, your organization's CCR MPIN is required.

- The application package will need to be downloaded from <u>www.Grants.gov</u> and all application MUST be submitted through <u>www.Grants.gov</u>.
- IMPORTANT: As part of the competitive process, any questions a potential applicant may have regarding any of the three FOAs MUST be submitted in writing via FedConnect, as the answers will be shared amongst all potential applicants.
- I CANNOT INTERPRET THE FOAS, PROVIDE ADVICE, OR ANSWER ANY QUESTIONS, REGARDLESS OF HOW INNOCUOUS THEY MAY SEEM. AS THIS IS A COMPETITIVE PROCESS, DOE, NREL, SNL, OR DOE CONTRACTORS ARE PROHIBITED FROM ASSISTING ANY APPLICANT IN PREPARING AN APPLICATION. We do not want to jeopardize the process and in extreme cases result in DOE cancelling of the FOAs. However, there is no prohibition in spreading the word about the potential opportunities.
