# **VACCARO FELLOW**

The U.S. EPA, Region III Michael F. Vaccaro Fellowship is open to U.S. citizens with excellent academic credentials, a strong interest in an environmental or public sector law career. Applications will be accepted from:

- current third year law students at an accredited law school, or
- recent graduates from an accredited law school, or
- current judicial clerks (one to two years out of an accredited law school)

Law school graduates who have been employed as an attorney will not be considered.

The Fellow is expected to commit to a two year term.

Michael F. Vaccaro, EPA's former Deputy Regional Counsel, died on Earth Day, April 22, 1996. He was a widely respected public servant with an unwavering commitment to good government. He was a graduate of Phillips Exeter Academy, Dartmouth College and Harvard Law School. He began working at EPA in 1973. His legacy lives on in the work of the Vaccaro Fellows.

# **FELLOWSHIP DESCRIPTION**

The Michael F. Vaccaro Honors Attorney Fellowship provides a unique opportunity to practice law in a major governmental environmental organization and to receive extensive training in and exposure to environmental law and policy work in the public sector.

The Fellowship recipient will work in the Office of Regional Counsel on particular matters arising under the major federal environmental statutes (such as the Clean Water Act, the Clean Air Act, Superfund, and the Resource Conservation and Recovery Act) and other federal statutes relevant to EPA Region III operations (such as the Ethics in Government Act, the Civil Rights Act, and the Freedom of Information Act). These matters typically require the development and application of emerging law and policy to significant environmental issues in Region III. The Fellowship will include an opportunity to manage environmental enforcement cases.

The next Fellowship begins in the Fall of 2013. The salary will be at the GS-11 level (currently starting at \$61,245) or, in unusual circumstances where appropriate qualifications exist, at the GS-12 level (currently starting at \$73,408).

#### APPLICATION PACKAGE

Beginning on September 1, 2012, Region III will begin accepting applications, on a rolling basis, for the 2013 Vaccaro Fellowship. Applications received after November 30, 2012, will only be considered if the position(s) have not been filled.

Interested applicants are encouraged to apply early and submit the following:

- a resume, listing significant accomplishments, work experience, class rank (or equivalent indicator of academic performance) and day and evening telephone numbers;
- an unofficial transcript of law school grades (official transcript must be provided at time of interview);
- 3. a cover letter explaining the applicant's interest in the Fellowship;
- 4. a writing sample; and
- 5. the name, address, and telephone number of three references. Included should be a current/former employer and a law school professor or advisor.

Selected applicants will be invited for interviews in Philadelphia (at the candidate's expense). Upon request, interviews may be conducted via videoconference. Interviews will be conducted on a rolling basis beginning in November 2012.
