1 Introduction

1.1 System Overview

The eDossier Builder system, developed by the Environmental Protection Agency (EPA) Office of Pesticide Programs (OPP), allows registrants to create packages for electronic submission in a user-friendly manner and presents packages to EPA systems in a specified format. Specifically, eDossier Builder allows registrants to create the following packages:

Registration Packages:

- New Product Registrations
- Experimental Use Permits
- Tolerance Petitions
- Distributor Products
- *Inert Ingredient Requests
- *Pre-Applications
- *FFS Waiver Requests

EDSP Packages:

- Individual order responses
- Consortia response for multiple orders

The package created consists of all documents and metadata that is required by EPA to properly process the package. Once all documents and metadata are provided, they are packaged together and stored in a single zip file for delivery to EPA.

1.2 Purpose

The purpose of this document is to provide instructions on how to use the eDossier Builder application. More precisely, the document provides instructions for installing the application, configuring the application, providing company profile information, creating a package, and completing other miscellaneous functions (e.g., viewing version information, viewing help, etc.).

1.3 Scope

The scope of this document is limited to the eDossier Builder application. All other applications are outside the scope of this document.

The document was developed using eDossier Builder v1.0 and will be updated as needed.

^{*} Regulatory type packages that are not supported by the current electronic submission system.

2 Installation

2.1 Prerequisites

The prerequisites for installing eDossier Builder include the following:

- Internet Explorer version 6.0, 7.0, or higher/Mozilla Firefox version 6.0 or higher/Chrome Browser version15.0.874.106 m or higher/Safari 5.1.1 or higher (Required for installing Adobe Air according to the installation instructions provided in section 2.2)
- Adobe AIR <u>version 3.0 or higher</u> (Installation instructions provided below in section 2.2). <u>Note</u>: <u>Adobe AIR might have its own systems requirements, which are out of scope of this document.</u>

2.2 Adobe AIR

- 1. Open **Internet Explorer** and go to http://get.adobe.com/air/
- 2. The *Adobe Air Download* web page appears. Select the **Download now** button.




Figure 2-1: Adobe AIR Download

3. The File Download – Security Warning window appears. Select the **Run** button.




Figure 2-2: File Download – Security Warning

5. The *Adobe AIR Setup* window appears. Select the **I Agree** button.




Figure 2-4: Adobe AIR – Installer Setup

While Adobe AIR is being installed, the Adobe AIR Setup – Installation Status window appears.




Figure 2-5: Adobe AIR – Installation Status

6. Once the installation has been completed, the *Adobe AIR Setup – Installation Completed* window appears. Select the **Finish** button.

2.3 eDossier Builder

Note 1: Uninstall any previous versions of eDossier Builder before installing version 1.0. Instructions for uninstalling the previous build are in section 2.3.2 of this document.

Note 2: Screen shots provided for installing and uninstalling, are taken using Windows XP Professional version 2002, screens for installing or uninstalling might vary for other operating systems.

2.3.1 Install

Note: Prior to installing, Adobe AIR must be installed on your computer. If not installed, follow the instructions provided in section 2.2 (Adobe AIR).

1. Open the eDossier Builder "exe" file.




Figure 2-7: eDossier Builder exe File

2. The Application Install screen appears.

Note: By default, both *Installation Preference* boxes are selected, and the *Installation Location* is set to **C:\Program Files.** Deselect any of the Installation Preferences you would like disable. If you would like to change the location of the application, select the **folder icon** and select another location.

Select the **Continue** button.

The *Application Install Progress* screen appears briefly appears while the application is being installed.




Figure 2-9: Application Install Progress

3. Once the application has finished installing, the *Application Install* screen will automatically close and the eDossier Builder *Home* screen appears. The application will not open if you chose for the application to not open at the completion of installation during step 5.




Figure 2-10: eDossier Builder Home Screen

2.3.2 Uninstall

If you would like to uninstall the application, follow the steps listed below. **Note:** Screen shots provided are for WindowsXP, screens for uninstalling might vary depending on the operating system used.

1. From your computer, select **Start > Control Panel**.

2. The *Control Panel* window appears. Select the **Add or Remove Programs** icon.




Figure 2-12: Control Panel

3. The *Add or Remove Programs* window appears. Select **eDossier Builder**, and then click the **Remove** button.




Figure 2-13: Add or Remove Programs




Figure 2-14: eDossier Builder Uninstall Progress

3 Open eDossier Builder & Using the Toolbar

3.1 Open eDossier Builder

- 1. Go to the location where eDossier Builder was placed during installation. By default, and if not changed during installation, an icon is provided on the computer desktop.
- 2. Click on the **eDossier Builder icon** to open the application.




Figure 3-1: eDossier Builder Icon

3. The *Home* screen appears.




Figure 3-2: Home Screen

4 Create, Edit, & Delete Company Profile

4.1 Create a Company Profile

Company Profile is the name given to the profile created in the 'Company Info' screen. This field can have numeric or string values, or any combination (e.g., alpha01). A minimum one Company profile is mandatory for creating an electronic package.

1. From the *Home* screen, select the **Company Info** button.




Figure 4-1: Company Info Selection

2. The *Company Profile* screen appears. Complete all **required fields** (*) and any of the other fields as necessary, and then select the **Add Profile** button.

Note: The Company and Contact Details are not meant to be the official company contact information.




Figure 4-2: Company Info Screen

3. The information entered is now provided in the *Company Information* table as shown below. Repeat step 2 if you would like to provide additional profiles. If no other company profiles are needed, select **Home** from the tool bar provided at the top of the screen.

4.14.2 Edit a Company Profile

1. From the *Company Profile* screen, select a profile that is provided in the *Company Information* table, and then click the **Edit Profile** button.




Figure 4-4: Edit Company Info

2. The previously entered profile name and company and contact details are provided in their associated fields located below the *Company Information* table. Make any **required changes**, and then select the **Save Profile** button.




Figure 4-5: Save Company Profile Changes




Figure 4-8: Delete Window

3. The previously provided company profile is removed from the *Company Information* table as shown below.




Figure 4-9: Company Profile Deleted

5 Create, Edit, and Delete a Non-EDSP Package

5.1 Create a Non-EDSP Package

1. From the *Home* screen, select the **Create a New Package** button.




Figure 5-1: Create a New Package

2. The *Confirmation Page* appears. Click **Yes** for creating a **EDSP package** or **No** for creating a **Non-EDSP package**.




Figure 5-2: Create a EDSP Package Yes or No

3. The *New Package for Non-EDSP Orders* screen appears. Complete all **required fields** (*) and any of the other fields as necessary, select the applicable **Regulatory Type** (i.e., Product Registration – Section 3) and **Application Type** (i.e., New Registration <u>and the number of applications to be added under each type</u>), and then select the **Next>** button.




Figure 5-3: Package Info

4. The *Document for the Package* screen appears. Complete all **required fields** (*) and any of the other fields as appropriate, and then select the **Add Document** button.

Note: A Package is the entire collection of documents/files being submitted at one time. A Package will include one or more applications each to fulfill a specific regulatory need (e.g., applications to register a section 3 product or EUP, application to amend section 3 registrations, or to submit a petition to establish tolerances).

Documents at the package level will apply to the entire set of one or more applications and typically include cover letters, fee payment receipts and OECD Dossier documents.

Documents at the application level will include the forms, labels, studies and other supporting documents/files specific to an individual application.




Figure 5-4: Add Package Document

4.5. The document information is provided in the *Documents* table as shown below.

Note: When adding multiple documents, the last document added will be placed at the bottom of the *Documents* table. Additionally, documents are not officially attached until the package is finalized.

Repeat step 4 if you would like to add additional documents to the package. Once you have added all of the documents, select the **View Summary** button to continue.




Figure 5-5: Package Document Added

5.6. The *Package [Title]* screen appears listing the package details, application information, and documents.

If you would like to provide or edit package metadata, follow the steps provided in section 5.4 (Add/Edit Package Metadata). If you would like to provide or edit package level documents, follow the steps provided in section 5.5 (Add/Edit Package Level Documents).

If you would like to provide and/or edit application metadata and documents, follow the steps provided in section 6 (Add, Edit, & Delete Application Metadata & Documents).

If you would like to finalize the package without adding or editing application metadata and documents, follow the steps provided in section 7 (Validate & Finalize a Non-EDSP Package).

5.2 Continue a Saved Non-EDSP Package

1. From the *Home* screen, select the **Continue Saved Package** button.




Figure 5-7: Continue Saved Non-EDSP Package

2. The *Open Package* screen appears and provides a listing of all packages. Click on one of the **packages** listed, and then select the **Open** button.




Figure 5-8: Open Package Screen

3. The *Package [Title]* screen appears. Continue with the creation of the package.




Figure 5-9: Package [Title] Screen




Figure 5-10: Package Details Add/Edit

If you would like to provide or edit package documents, select the **Next>** button and go to step 2 of section 5.5 (Add/Edit Package Level Documents).




Figure 5-11: Edit Package Info

3. The *Package* [*Title*] screen appears and the changes made are provided in *Package Details*.




Figure 5-12: Package Info Change

1. From the *Package [Title]* screen, select the **Add/Edit** button provided next to *Documents*.




Figure 5-13: Package Document Add/Edit

If you would like to delete a document, select the **Delete Document** button.

When complete, select the View Summary button.

Note: If adding multiple documents, the last document added will be placed at the bottom of the *Documents* table.

Note, the documents are not officially attached until the package is finalized.




Figure 5-14: Edit Package Document

3. The *Package [Title]* screen appears and the changes made are provided in *Documents*.




Figure 5-15: Package [Title] Screen

1. From the *Package [Title]* screen, click on a **document name** provided in the *Documents* table.




Figure 5-16: Select Package Document

2. The File Download window appears. Select the **Open** button.




Figure 5-17: File Download Window

3. The document opens in Internet Explorer as demonstrated below.




Figure 5-18: Package Level Document




Figure 5-20: Package Deletion




Figure 5-22: Package Deleted

6 Add, Edit, & Delete Non-EDSP Application Metadata& Documents

6.1 Provide an Application Title

1. From the *Package [Title]* screen, click on one of the **Application Types** listed in the tree view on the left side of the screen.

2. The Application Type details, metadata, and documents appear on the right side of the screen as shown below. Select the **Add/Edit** button provided next to *Application Details*.




Figure 6-2: Application Details Add/Edit

If you would like to provide or edit the Application Metadata, select the **Next>** button and go to step 2 of section 6.2 (Add/Edit Application Metadata) to continue.




Figure 6-3: Application Information




Figure 6-5: Application Metadata Add/Edit




Figure 6-6: Application Metadata Screen




Figure 6-7: Application Metadata Added




Figure 6-8: Application Metadata Mark For Review




Figure 6-9: Application Metadata Marked for Review




Figure 6-10: Marked for Review




Figure 6-12: Add Application Document




Figure 6-13: Application Document Added




Figure 6-14: Package [Title] Screen




Figure 6-15: Document Metadata Marked for Review




Figure 6-18: Select Application Document for Opening




Figure 6-19: File Download Window




Figure 6-20: Application Level Document




Figure 6-21: Add Application




Figure 6-22: Add Application




Figure 6-23: Add Application




Figure 6-24: Application Level Document




Figure 6-25: Application Level Document




Figure 6-27: Application Selection & Deletion




Figure 7-1: Package Validate Button

If not, a message appears stating "The package has been processed successfully." Select the **Finalize** button.

Note: Once a package is finalized, it can no longer be edited. The package can be 'Reviewed' before finalizing the package.




Figure 7-2: Package Validation Summary




Figure 8-1: Package Info




Figure 8-2: Add Package Document




Figure 8-3: Package Document Added




Figure 8-4: Package [Title] Screen




Figure 8-5: Continue Saved Package




Figure 8-6: Open Package Screen




Figure 8-8: Package Details Add/Edit




Figure 8-9: Edit Package Info




Figure 8-10: Package Info Change




Figure 8-11: Package Document Add/Edit




Figure 8-12: Edit Package Document




Figure 8-13: Package [Title] Screen




Figure 8-14: Documents Screen




Figure 8-15: Package [Title] Screen




Figure 8-17: Select Package Document




Figure 8-18: File Download Window




Figure 8-19: Package Level Document




Figure 9-1: Package Validate Button




Figure 9-2: Package Validation Summary




Figure 9-3: Package Creation Successful




Figure 10-2: Home Screen




Figure 11-1: Field Tooltip




Figure 11-2: Help Link




Figure 11-3: Non-EDSP Help Details




Figure 11-4: EDSP Help Details

12.1 Package Storage Location

By default, the package you create will be stored at C:\Documents and Settings\username\edb. Follow the steps listed below if you would like to view this setting and/or change the storage location.




Figure 12-2: Configuration Settings

12.2 Application Font Size




Figure 12-7: Configuration Settings – Font Size

12.2.2 Current Session
