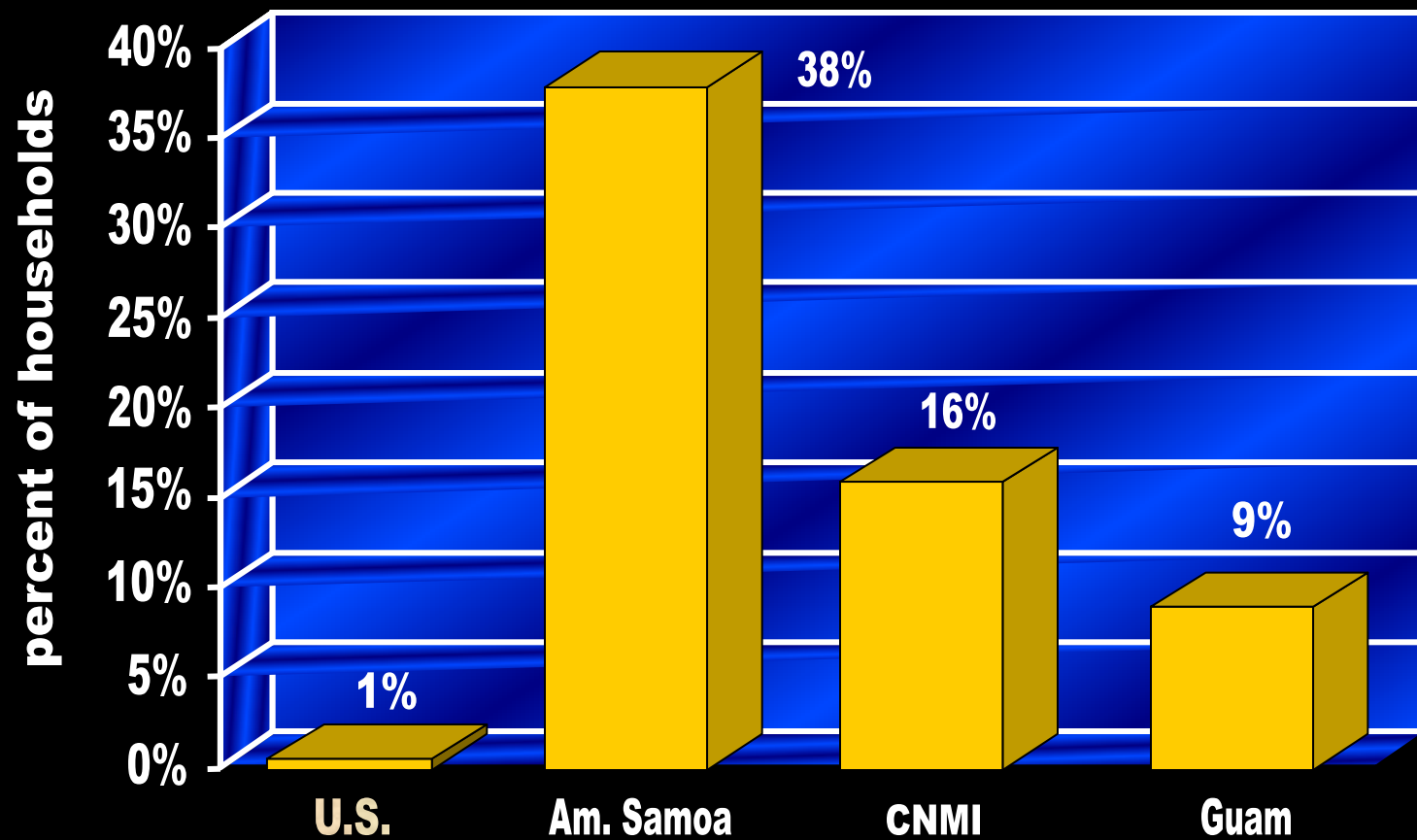
Broken drinking water pipe covered in raw sewage

DRINKING WATER IN PACIFIC ISLANDS

- **Water rationing; unsafe or unpalatable water common indoor plumbing**
- **Saipan is the only municipality in the U.S. without 24-hour water**
- **Gap between current funding and need is huge and growing**
- **High potential for waterborne disease outbreak**



COMMUNITIES LACKING COMPLETE PLUMBING FACILITIES



SAIPAN's DRINKING WATER CHALLENGES

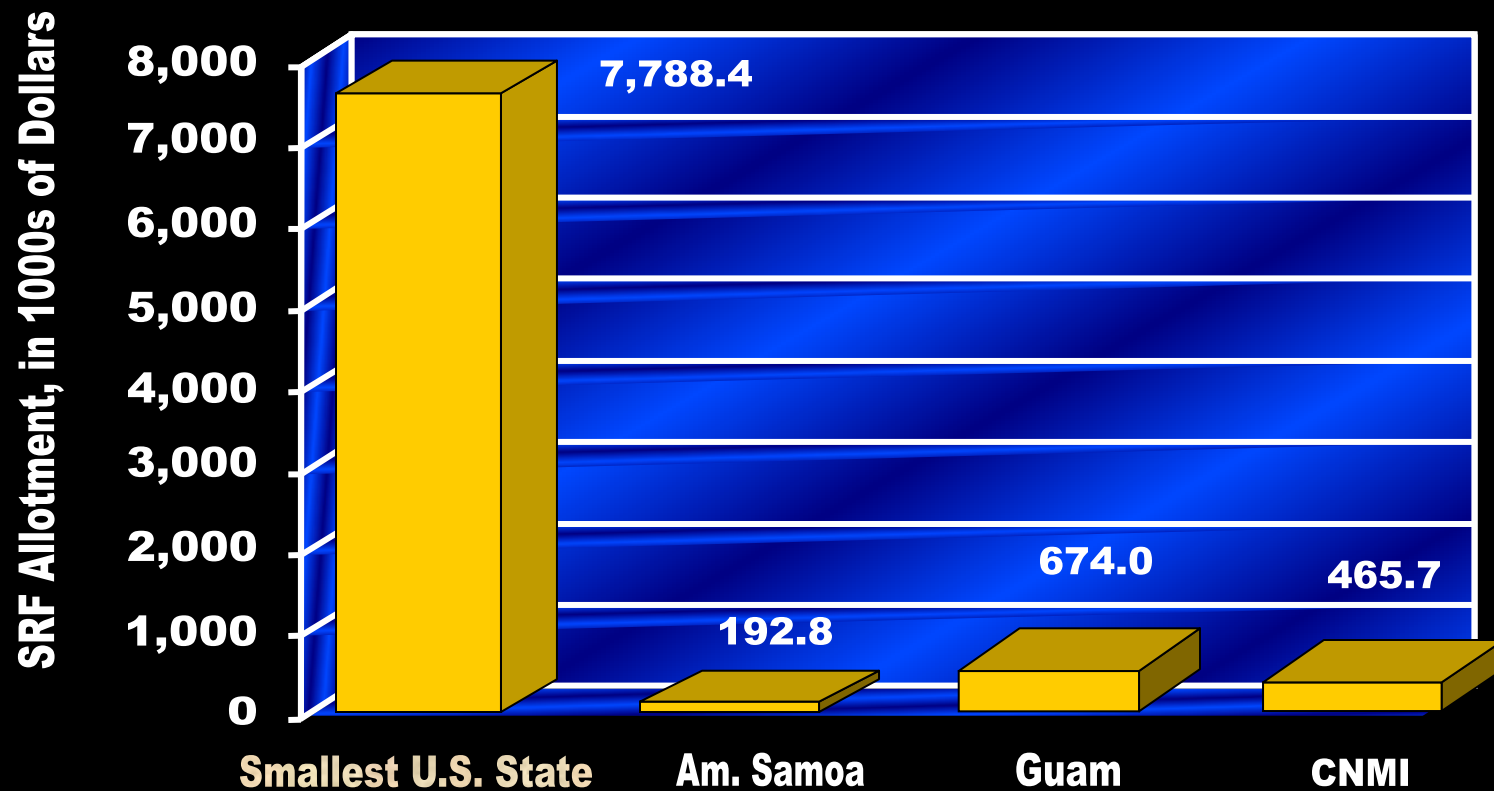
- Residents cannot drink the water; too salty
- 45% of residents don't have access to running water 24/7
- Cost to fix - \$90 million



EPA INFRASTRUCTURE FUNDING

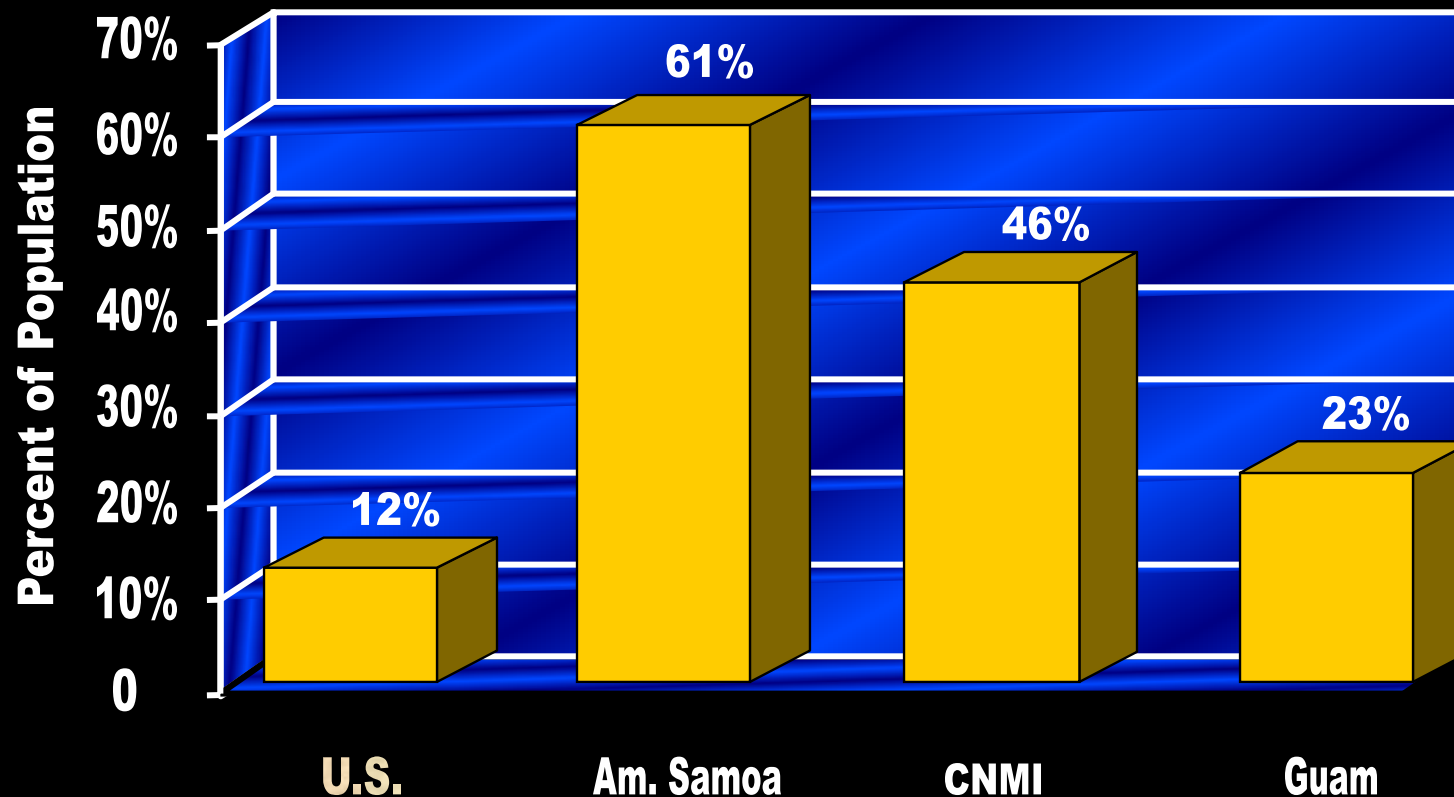
- Funds disproportionately low for smaller islands

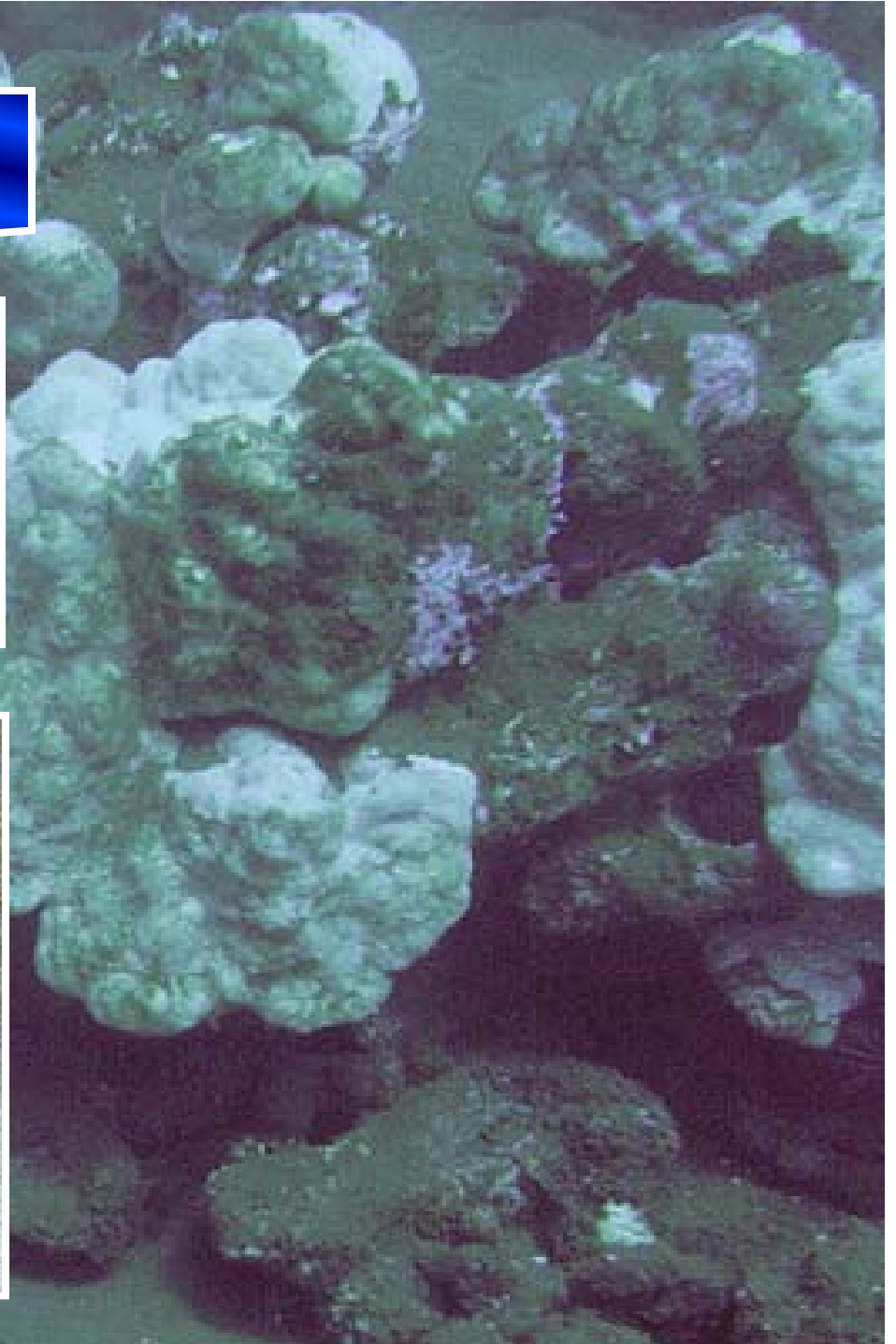

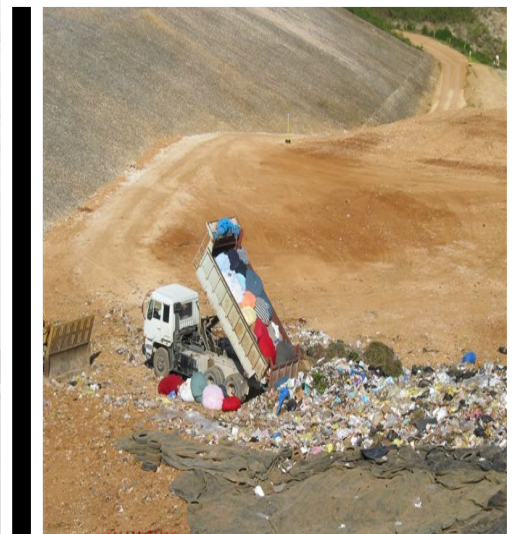
- Coastal NPS Program Approval

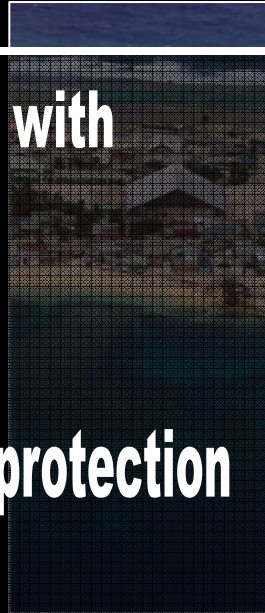

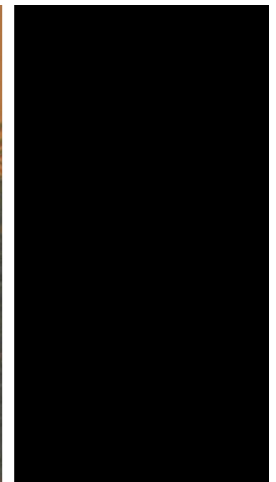
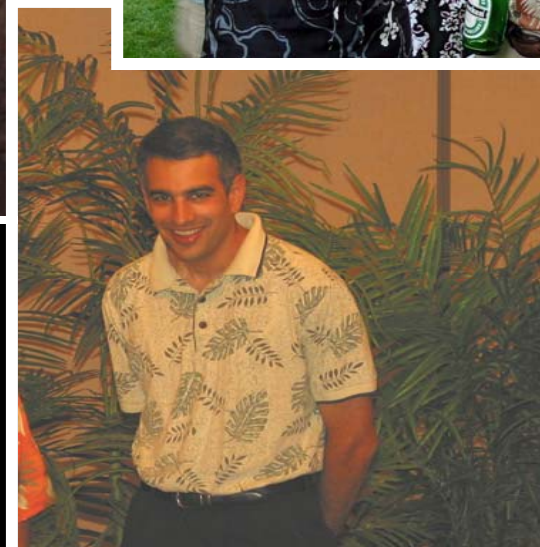
