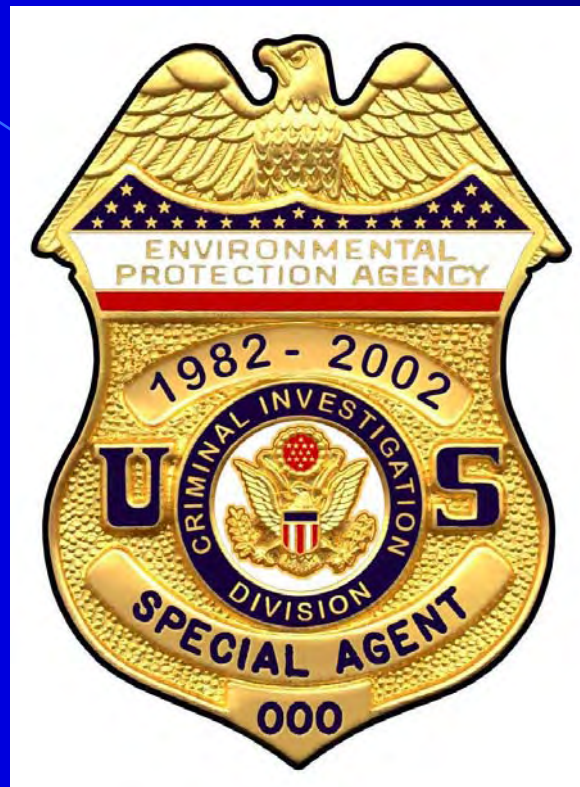

DISCHARGE OF OIL

PROHIBITED

The Federal Water Pollution Control Act prohibits the discharge of oil or oily waste into or upon the navigable waters of the United States or the waters of the contiguous zone if such discharge causes a film or sheen upon or discoloration of the surface of the water or raises a sludge or emulsion beneath the surface of the water. Violators are subject to a penalty of \$5,000.

“기름배출의 금지”

미국연방 수질오염규제법은 미합중국의 가항수역, 인접수역에 기름 및 기름성인 물의 배출을 금지하고 있다. 그 같은 배출에 의해 수면이 박막(薄膜), 광휘(光輝), 변색(變色)을 일으키거나 혹은 수면이 유화(乳化), 니화(泥化)를 일으킨 경우에는 위반자에 대해 \$5,000 벌금이 부과된다.

THE USE OF CHEMICAL DISPERSANTS TO DEAL WITH OIL DISCHARGES IS PROHIBITED IN UNITED STATES NAVIGABLE WATERS WITHOUT THE PRIOR CONSENT OF THE USCG ON-SCENE COORDINATOR.
