

# PUBLIC NOTICE

## Requesting Information about Historic Properties Under Section 106 of the National Historic Preservation Act

Romic Southwest is a hazardous waste storage and treatment facility on the Gila River Indian Community near Chandler, Arizona. The Environmental Protection Agency (EPA) is in the process of making a permit decision at Romic.

As part of the permit decision, EPA must comply with the National Historic Preservation Act (NHPA). In compliance with the NHPA, EPA has designated an Area of Potential Effects as shown on the map to the right. EPA is today requesting information about historic properties within the Area of Potential Effects.

EPA established the Area of Potential Effects after consultation with the Gila River Indian Community, the Arizona State Historic Preservation Office, the Bureau of Indian Affairs, and Romic, and after providing it in draft to the public in August 2004.

EPA must now determine whether there are any historic properties within the Area of Potential Effects. After researching public records, EPA has found no historic properties in this area. EPA would like to hear from you about any historic properties that you know of within the Area of Potential Effects. The term "historic properties" includes properties of traditional religious and cultural importance to an Indian Tribe. If EPA determines that there are historic properties within the Area of Potential Effects, the next steps will be to decide whether Romic may cause adverse effects to those properties. If there may be adverse effects, then EPA must take those adverse effects into consideration during the permit decision.

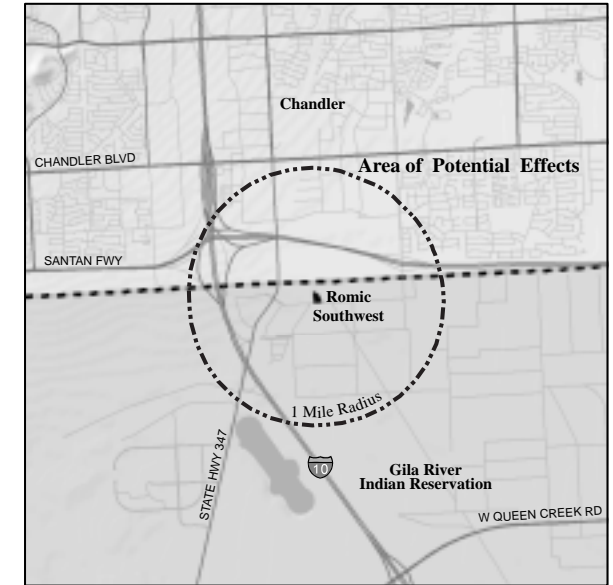

Also, you may contact EPA at any time during the process to advise us of concerns or comments you may have regarding the NHPA process at Romic.
