It will also focus on the direction of the improvement of the quality of life, governance, progress of what all stakeholders have been taking and will take into their future roadmap to sustainable development. The presentation provides an overview of a risk-based approach to adaptation and thence to sustainable development. Benefits of such an approach include the fact that risk is a familiar concept and most countries already have policies and plans to manage risks (e.g. financial, human health, and energy supply risks). The approach includes formal assessment of the likelihood of future extreme events or variations in climate and allows aggregation of the anticipated climatic conditions over a specified time period in the future, rather than just focusing on individual events (e.g. an extreme rainstorm or a cyclone) or on a future date.
